





Review of the City's Internal Service Fund (ISF) Reserves

Internal Service Funds account for goods and services provided by a centralized city department/service to other city departments/funds. The City of Garden Grove established eight internal service funds and Revenue & Cost Specialists (RCS) was retained to evaluate the proper reserve level for each fund.

The three primary purposes of a reserve are (1) to provide a contingency reserve, (2) act as a stabilization reserve, and (3) set-aside reserves for future expenses. Revenue and Cost Specialists recommend establishing reserve levels for each of the funds:

| Internal Service Fund | Recommended Reserve |
|--------------------------------|--|
| Worker's Compensation Fund | 90% Confidence level of Actuarial Study |
| Fleet Management Fund | 50% of current replacement cost |
| Employee Benefits Fund | 100% of accrued compensated absences |
| Information Systems Fund | 50% of current replacement cost |
| Warehouse Operations Fund | 50% of total operating expenses |
| Telephone System Fund | 100% of replacement cost at expected end of life |
| Risk Management Fund | 90% Confidence level of Actuarial Study plus \$12 Million Catastrophic Loss Contingency |
| Communication Replacement Fund | 100% of replacement cost at expected end of life |

RCS recommends that the City Council adopt, by Resolution, reserve policies for the General Fund and all Internal Service Funds. The reserve policies should account for the reserve levels, purpose, authorization, and procedures for use. These reserves should be committed for specific purposes and may only be used with Council approval. Changes to reserve levels may only occur by Council action. There should be no intent to utilize internal service fund reserves for operating expenses.



RCS recommends establishing policy to buy down the pension liability. The City's CAFR ending June 30, 2016, Note 10 (pages 65-73), identifies Garden Grove's net pension liability as \$73.4 million for Miscellaneous employees and \$136.1 million for Safety employees. The combined \$209.4 million is a significant burden for the City, which must be addressed in addition to increasing CalPERS payments and labor costs. Garden Grove may consider creating a Pension & OPEB Liability internal service fund to help pay down the obligation.

INTRODUCTION

BACKGROUND

Revenue and Cost Specialists was established in 1980, specializing in revenue analysis and cost studies. The company was started by two former City Managers and a Finance Director, and the current four principles of the company have assisted over 220 California agencies with various studies.

Like most California cities, Garden Grove is facing the fiscal crisis of rising pension costs, aging infrastructure, and few suitable revenue options. There is an ongoing movement to improve fiscal transparency and professionalism of the municipal finance functions.

The City of Garden Grove currently does not have a reserve policy for the internal service funds, which have a combined net asset of \$70.3 million. The money may be completely depleted due to the lack of policy.

In accordance with the scope of work below, this report provides the City Council, City management, and the general public with independent and objective information regarding the financial condition and recommendations for City internal service fund reserves.

SCOPE OF WORK

In recommending the appropriate reserve levels, Revenue and Cost Specialists agreed to perform the following:

- Review City documents, including Budgets, Annual Financial Reports, and other relevant reports, to determine the current financial information for each Internal Service Fund.
- Interview City staff where needed to answer questions.
- Prepare a Report with a recommended reserve level for each Internal Service Fund with supporting text and documentation
- Present the Final Report and recommendations to the City Council.

This report focuses on the review and recommendation of ISF reserve levels. RCS did not evaluate the City's general fund reserve, or the efficiencies and effectiveness of the internal service fund operations.



METHODOLOGY

TERMINOLOGY – INTERNAL SERVICE FUNDS

The City of Garden Grove maintains eight Internal Service Funds (ISF) to account for goods and services provided by a centralized service to other city departments/funds. ISF are established to avoid duplication of effort and save on costs for the City. Garden Grove's Internal Service Funds are listed below.

Workers' Compensation Fund

The City's self-funded workers' compensation program, which is accounted for in this fund, is financed by charges to all City departments based on the number and classification of employees. Expenses include operating costs and all payments relating to injured employees.

Fleet Management Fund

The costs of operating and maintaining City owned vehicles and other gasoline-powered equipment are accounted for in this fund. The fund is financed by charges to the various City departments for actual cost plus a contributory sum for vehicles/equipment replacement. Actual costs include depreciation, maintenance and other factors necessary for the provision of the service.

Employee Benefits Fund

This fund encompasses all other employee benefits such as retirement contributions, health, dental, disability, life insurance, and sick leave, vacation, and other paid leaves. Revenues for this fund are derived from periodic charges to all departments based on the number of employees, length of service and insurance coverage. Funds are used to pay actual expenses and to accrue existing liabilities.

Information Systems Fund

This fund encompasses the cost of operating and maintaining the City's computer system. The fund is financed by charges to the various City departments based on computer usage.

Warehouse Operations Fund

This fund is used to account for the provision of materials and supplies to the various City departments. Financing is provided by the user departments through payment of costs of material and supplies plus an overhead charge.



Telephone System Fund

This fund accounts for the operation of the City's telephone system. The financing comes from charges to the various City departments based on actual toll charges and the lease cost prorated on the number of instruments.

Risk Management Fund

This fund is used to account for the City's self-insured liability program and for the purchase of various types of property and casualty insurance protection as required by the City. The funds are used to pay any liability losses, program operating costs, insurance premiums and insurance deductibles. Revenues for this fund are generated from assessments made to all City departments for their pro-rata share of the total costs of the insurance administration program.

Communication Replacement Fund

This fund is used to account for both the operating and capital costs of the City's communication system in relation to the county-wide 800MHZ backbone project. Funds are used to pay for the City's backbone costs and the capital costs incurred to upgrade its communications equipment to integrate with the county-wide communications system. The financing comes from charges to the various City departments based on an allocation of actual costs. Actual costs include depreciation and maintenance.

TERMINOLOGY - RESERVES AND FUND BALANCE

Reserve and fund balance are terms commonly used synonymously, yet often misunderstood and causing confusion among individuals. In discussing reserves, the Government Accounting Standards Board (GASB) states:

It is common practice for governments to put aside resources to be used in a financial emergency. By turns called rainy-day funds, stabilization funds, emergency funds, contingency funds, and so on, these funds all are intended to provide needed monies should a government find itself facing unexpected financial problems.

Net position or cash and equivalents, as presented in the Comprehensive Annual Financial Report, may cause confusion for readers because these numbers are different than the actual or projected fund balances stated within the budget document.

To reduce the amount of confusion, GASB issued Statement 54, defining fund balance as a hierarchy of five classifications. These five classifications are based on the extent to which the agency is bound to honor constraints imposed upon the use of the resources. The first two classifications of Non-Spendable and Restricted categories are more restrictive, while the remaining three classifications of Committed, Assigned and Unassigned are self-imposed restrictions that the governing board may change.



Implementation of GASB Statement 54 improved financial reporting by reducing confusion among the variations of fund balance and enhancing consistency of financial reporting among agencies.

For reference, the Garden Grove Comprehensive Annual Financial Report (CAFR) ending June 30, 2016 reports the General Fund unassigned fund balance at \$18,330,551, representing 18% of the fund's operating revenues (Appendix A).

Whereas GASB Statement 54 requires the General Fund to designate fund balances within the five classifications on the left side of the table above, it requires enterprise funds and internal service funds to report net assets as restricted and unrestricted as shown on the right side of the table.

BEST PRACTICE – ESTABLISHING RESERVE GUIDELINES

GFOA provides fund balance guidelines only for the General Fund (Appendix B), but none for internal service funds. For the General Fund, GFOA recommends a reserve with a minimum fund balance of 17% (two months of regular operating revenues or expenditures) for the majority of funds.

Based on RCS' prior work experience with California cities, a 17% General Fund unassigned fund balance is marginally adequate, not preparing the City for major financial impact such as the dissolution of redevelopment agencies and the dramatic increase in employee costs. Another global financial crisis can make a two-month reserve disappear quickly. Cities who can maintain a General Fund assigned and unassigned balance of 50% or greater are better off financially. In determining the appropriate reserve level, an agency should consider a variety of factors, including:



- The predictability of its revenues and the volatility of its expenditures;
- Its perceived exposure to significant one-time outlays;
- The potential drain upon resources from other funds, as well as, the availability of resources in other funds;
- The potential impact on the entity's bond ratings and the corresponding increased cost of borrowed funds: and
- Commitments and assignments

Garden Grove can should consider these factors in developing its ISF reserve policies. In addition, a proper reserve for ISF provides three purposes.

- 1. <u>Contingency</u> The money is not anticipated to be drawn against unless for emergency. Cities sometimes refer to this as the rainy-day fund or emergency fund.
- 2. <u>Stabilization</u> Committed or assigned monies are established to stabilize the annual budget when revenues fall short of projections or expenditures are higher than estimated. This purpose is useful in the annual operations where expenses for vehicle purchases, facility repairs and technology systems vary significantly from year to year.
- 3. <u>Set-Aside</u> Money is incrementally set-aside, knowing that a major expense will occur in a future year. Cities can set aside money for construction of a facility, replace an aging multimillion dollar communications system, or pay for a street repair program. Cities may often refer to this as designation or earmarks.

BEST PRACTICE - DEVELOPING COMPREHENSIVE POLICY

In addition to establishing the proper reserve level, GFOA provides guidance in developing policies that define acceptable use and management. More comprehensive policies provide clearer guidance on the use and management of the reserves.

REVIEW OF CITY DOCUMENTS AND REPORTS

RCS reviewed the following Garden Grove documents either available online or provided by City staff. The focus was to look for existing reserve policies and review current funding levels. RCS could not find any existing reserve policy for the City.

INTERVIEW OF KEY GARDEN GROVE STAFF

RCS scheduled meetings with various City staff and elected officials. These include:

- Service Recipients Police, Fire and Community Development departments, who are major ISF service recipients of vehicle and workers compensation services.
- Service Provider Public Works and Information Technology, who provide centralized services such as fleet management and computer system replacement.
- ISF Financial Administrator Finance, which is responsible for the appropriation, administration and financial reporting for these funds.
- Policy Maker City Manager, City Attorney and City Council members, who are ultimately responsible for the City's financial condition.

PEER SURVEY

Through phone conversations, email correspondences and web searches, RCS reviewed and evaluated reserve polices from other cities. Overall, there is no consistency in the types of



internal service funds among agencies, the reserve levels for such funds, and/or even the adoption of any policy. Since the ISF reserve policy is not a statutory requirement, municipal agencies all treat the issue differently.

Members of the California Society of Municipal Finance Officer Association (CSMFO) often conduct surveys among its 2,000 members, representing over 300 agencies, on all municipal fiscal matters. A recent survey by the City of Orange summarized 17 agencies' reserve policies (Appendix H) for the General Fund and Internal Service Funds. For the General Fund, the various agencies have a reserve range of 5% minimum to 60% maximum, with 20% being the most common level. Some agencies define reserves as economic uncertainties, emergency/disaster, catastrophic or contingency. Only eight of the responding 17 agencies have ISF reserve policies, however the reserve levels vary significantly among the agencies. The City of Pittsburg, California established within their municipal code ISF reserves equal to 30% of all respective operating budget expenses. The City of Newport Beach approved by City Council resolution a compensated absence reserve policy equal to 50% of it's long-term liability. The City of Mission Viejo has reserve policy for its computer, equipment and vehicle internal service funds, however those reserves are kept within the General Fund.

La Palma's previous Finance Director shared his working documents of their 2013 reserve policy update (Appendix I). Prior to updating its reserve policy, La Palma had a 100% General Fund reserve, but after the loss of a major revenue source the La Palma City Council and management updated the reserve policy. With the General Fund, La Habra established a 60% Economic Uncertainties Reserve and 40% Capital Projects Reserve. Internal Service Fund reserves were adopted as follow:

- Employee Benefits ISF 100% of compensated absences balance
- Insurance ISF 3x annual insurance expense
- Vehicle Replacement ISF 33% of replacement value
- Facilities Maintenance/Replacement ISF 50% of rolling 6-year average of expenses
- IT Maintenance/Replacement ISF 100% of replacement value of IT network

La Palma's updated reserve policy also included language to replenish reserves within 1-3 years when it falls below policy.



RECOMMENDATIONS

The recommendations presented in this report are specific to the City of Garden Grove. Each city operates differently and has its unique fund structure, financial policies and expectations. Applying these recommendations to a cash poor city is not feasible, however, Garden Grove is fortunate to have healthy ISF reserves.

RCS is recommending optimal target reserve levels, rather than a minimum or maximum. For some cities, a reserve policy functions as a target for the city to achieve and maintain. Once the reserve level is met, the city may continue to go beyond the target levels. For Garden Grove, the recommended reserve levels have already been surpassed, so the City must decide what to do with excess funds.

RCS' recommendations are a balance between operational efficiency, maintaining Garden Grove's healthy reserve levels and developing a successful process to simplify the calculation and maintenance of the reserves.

Establishing reserve levels obligates the City to properly charge departments for its internal service fund operations. In other words, if the City does not charge departments enough for telephone system maintenance and replacement, soon the telephone ISF fund will not have enough fund balance and fall below the reserve level. This will compel the City to increase the amounts charged to departments.

It is important to note that, during an emergency, operational efficiency and cost savings is not the main priority of any organization. After a natural disaster, the focus of the city is to protect the lives of its residents and restore necessary infrastructure as soon as possible. Emergency purchasing decisions will be made, and necessary goods may cost more than usual. Restoring the local economy after a natural disaster is also a challenge. If businesses do not have the financial resources to rebuild, or decide to move to another city, then the City's tax base will see a decline. RCS's recommendations take into consideration the fiscal impact of a natural disaster or fiscal emergency.

Workers' Compensation ISF

RCS recommends conservatively setting the Workers' Compensation Fund reserve equal to the 90% Confidence level, as presented in the 2015 Bickmore Workers' Compensation report (Appendix C, Page 4). That amount was \$34,755,000 at time of report publishing. The primary purpose of the Worker's Compensation ISF reserve is to set-aside funds for all current and future workers' compensation claims.

"[B]ickmore recommends the 75% to 85% confidence level range because the probabilities are reasonably high that resulting assets will be sufficient to meet claim liabilities, yet the required risk margins are not so large that they will cause most self-insured entities to experience undue financial hardship." Since the City has a healthy cash balance in the Workers' Compensation ISF, RCS recommends establishing the reserve at a more conservative 90%. A reserve any higher would put undue financial strain on the City. As



presented in the table below, the difference between the 90% and 95% confidence level is an additional \$3 million.

Garden Grove is a self-funded agency, and does not participate in a risk-sharing joint powers authority. This means the City is responsible for all aspects of its workers' compensation claims. The City is fortunate to have a high reserve, and with a 90% confidence level, there is not much volatility that will significantly affect the City's financial standing. Since the City employs over 850 employees, and any worker's comp claim will be paid over a number of years, no single new claim should destabilize the fund. Maintaining a conservative reserve level is desirable for Garden Grove's credit ratings, and provides financial stability in the area of workers' compensation.

In the City's CARF ending June 30, 2016 Combining Statement of Cash Flows for Internal Service Funds, the Workers' Compensation ISF reports Cash and cash equivalents, end of year at \$38,694,570. This ISF fund currently meets and exceeds the recommended reserve level by \$3,649,570.

Fleet Management ISF

RCS recommends setting the Fleet Management Fund reserve at 50% of current replacement cost for all fleet vehicle and equipment. The primary purpose of the Fleet Management ISF reserve is to pay for the replacement of existing vehicles as they reach the end of their useful life or for major repairs that extend the useful life of the vehicle. Having a 50% reserve in addition to the existing fleet is adequate to keep the City's vehicles rolling, even after a catastrophic emergency.

Monies are also used to stabilize budgeting expenses and annual ISF charges to departments. The City manages over 450 items of vehicle and equipment in the Fleet Management program. Based on staff projections, total replacement cost for all vehicles is \$31.1 million (Appendix E).



A city with zero financial capacity may choose to operate with no reserve, using a pay-asyou-go method, or leasing all of its fleet. A financially healthy city may choose to set aside a reserve equivalent to several years of purchases. For instance, the City of Garden Grove purchased \$4.2 million in capital outlay for the fiscal years 2013-14 through 2015-16.

Since Garden Grove is fortunate to have a healthy reserve, RCS recommends a reserve equal to 50%, of total replacement costs for all vehicles, or \$15.6 million. This provides assurance to all departments that their fleet are funded for replacement. The most conservative option is to establish the fleet ISF reserve policy at 100% of total replacement costs.

In the City's CARF ending June 30, 2016 Combining Statement of Cash Flows for Internal Service Funds, the Fleet Management ISF reports Cash and cash equivalents, end of year at \$24,050,963. This ISF fund currently meets and exceeds the recommended reserve level by \$8,300,963.

Employee Benefits ISF

RCS recommends setting the Employee Benefits Fund reserve at 100% of the accrued compensated absences. Employees have the option of receiving cash-out payments for some accumulated leave balances, and the Employee Benefits ISF reserve sets aside those funds for the employees. It is highly unlikely that the full amount would come due at once, however establishing the reserve at 100% gives employees a sense of certainty, that the funds are there when needed.

The reserves will also help stabilize budgeting expenses and annual ISF charges to departments. The City of Newport Beach has a compensated absence reserve equal to 50% of long-term liability, and this is acceptable, as cities will likely never have to pay for all its leave balances at one time.

In the City's CARF ending June 30, 2016 Combining Statement of Cash Flows for Internal Service Funds, the Employee Benefits ISF reports Cash and cash equivalents, end of year at \$13,566,050. The Combining Statement of Net Position reports current and noncurrent accrued compensated absence at \$10,027,245. This means the Employee Benefits fund currently meet and exceed the recommended reserve level by \$3,538,805.

Information Systems ISF

RCS recommends setting the Information Systems Fund reserve at 50% of current replacement cost for IT assets. The primary purpose of the Information System ISF reserve is to stabilize budgeting expenses and annual ISF charges to departments. Appendix F is a draft list of all City technology equipment, presenting a total replacement cost of \$8.8 million and an annualized replacement cost of \$1.1 million.

Annually, the City needs to collect from operating departments an average \$1.1 million for IT replacement plus approximately \$2.0 million for IT operations. The CAFR shows the Information Systems Fund collected \$2.2 million in FY 2015-16, therefore IT internal charges



to department should increase. RCS could not determine if there is additional IT equipment budgeted directly within each department.

Upgrading the Finance Enterprise Resource Planning (ERP) system, estimated at \$4.0 million, would completely deplete most of the fund's reserve. With a 10-year life cycle, the City needs to set aside \$400,000 annually for the system. If the City was able to collect \$1.1 million per year for IT replacement, the remaining \$700,000 would be adequate funding to replace all the other IT equipment.

Alternative reserve levels could be three years of fund expenditures, or 100% of total replacement costs.

A 50% reserve level is equivalent to \$4,400,000. In the City's CARF ending June 30, 2016 Combining Statement of Cash Flows for Internal Service Funds, the Information Systems ISF reports Cash and cash equivalents, end of year at \$3,106,999. This ISF fund is \$1,293,001 short of meeting the reserve level.

Warehouse Operations ISF

RCS recommends setting the Warehouse Operations Fund reserve at 50% of its total operating expenses. The primary purpose of the Warehouse Operations ISF reserve is to stabilize budgeting expenses and annual ISF charges to departments. The warehouse operating expenses are only \$280,000 per year, so the City may consider eliminating this internal service function if there are not enough financial/operational efficiencies identified. Combining it with other Finance department functions, the City can still recover costs from other funds through proper overhead charges.

In the City's CARF ending June 30, 2016 Combining Statement of Cash Flows for Internal Service Funds, the Warehouse Operations ISF reports Cash and cash equivalents, end of year at \$644,575. This ISF fund currently meets and exceeds the recommended reserve level by \$505,445. Alternative reserve levels could be two months of operating expenses, or 100% of operating revenues.

Telephone System ISF

RCS recommends setting the Telephone System Fund reserve at 100% of the Citywide telephone system at the end of its life expectancy. The primary purpose of the Telephone System ISF reserve is to set-aside funds to replace the telephone system. Total replacement cost is estimated between \$500,000 and \$1,000,000. This internal service fund/program accounts for maintenance and operations of the citywide phone system, telephone use charges, cellular equipment, cellular use charges and staffing to run this operation.

Alternative reserve levels could be three years of fund expenditures, or 100% of total replacement costs at all time.



In the City's CARF ending June 30, 2016 Combining Statement of Cash Flows for Internal Service Funds, the Telephone System ISF reports Cash and cash equivalents, end of year at \$1,974,304. This is an adequate amount to replace the existing telephone system.

Risk Management ISF

RCS recommends setting the Risk Management Fund reserve equal to the 90% Confidence level for 2017 presented in the 2015 Bickmore General Liability report, equal to \$7,079,000, plus an additional \$12.0 million for economic uncertainties. The primary purpose of the Risk Management ISF reserve is to set-aside funds for current and future liability claims as well as any catastrophic event which may occur in the City.

Bickmore recommends setting aside assets to the 75% to 85% confidence level, further stating that funding to the 70% confidence level is marginally acceptable and 90% or greater is conservative. The City maintains a self-insured retention level of \$2,000,000, and purchases excess insurance for claims above \$2 million. Between 1994 and 2015, Garden Grove averaged 125 claims per year and \$902,000 in annual payments for claims (Appendix D, pages 87 & 89).

In the City's CARF ending June 30, 2016 Combining Statement of Cash Flows for Internal Service Funds, the Risk Management ISF reports Cash and cash equivalents, end of year at \$22,836,927. This ISF fund currently meets and exceeds the recommended reserve level by \$3,757,927.

Communication Replacement ISF

RCS recommends setting the Communication Replacement Fund reserve at 100% of the Citywide communication system at the end of its life expectancy. The primary purpose of the Communication Replacement ISF reserve is to set-aside funds to replace the communication system when needed. The cost of the recently purchased 800MHz radio system is approximately \$4.0 million. If the life expectancy for this new system is 10 years, the City should set-aside \$400,000 each year until 100% of replacement cost is reached.



Through a \$4.0 million loan from the Fleet Management fund, there are funds available to purchase and install the new 800MHz communication system. The City must address how to pay back the loan and set aside enough funds for the next system replacement.

Alternative reserve levels could be three years of fund expenditures, or 100% of total replacement costs.

Adopt Reserve Policy

RCS recommends that the City Council adopt, by Resolution, a reserve policy for the General Fund and all Internal Service Funds. These reserves should be committed for specific purposes and may only be used with Council approval. Changes to reserve levels may only occur by Council action.

Each Internal Service Fund reserve should remain within 5% of the recommended target. The City should seek to return to the recommended reserve levels within 1 to 3 years. Through the budget process and Council action, staff can adjust the annual ISF allocation charges to departments, or transfer funds to/from another fund.

The adopted budget should include pertinent information about internal service fund revenue sources, expenditure details, fund balance, staffing, special projects, multi-year expenditure projections for capital items, reserve levels and reserve policies. Attachments to this report includes examples of ISF allocation schedule and policies.

There should be no intent to utilize internal service fund reserves for operating expenses. The use of current internal service funds for any purpose described is subject to prior financial analysis and legal review.

RCS recommends establishing policy to buy down the pension liability. The City's CAFR ending June 30, 2016, Note 10 (pages 65-73), identifies Garden Grove's net pension liability as \$73.4 million for Miscellaneous employees and \$136.1 million for Safety employees. The combined \$209.4 million is a significant burden for the City, which must be addressed in addition to increasing CalPERS payments and labor costs. Garden Grove may consider creating a Pension & OPEB Liability internal service fund to help pay down the obligation.

RCS suggests an initial deposit to a facilities replacement internal service fund to deal with the city's aging structures. Having a centralized accounting of all the city's buildings, furniture, fixtures and equipment would help identify the true cost to maintain, repair, and replace the facilities. They are an essential part of city operations, and funds should be set aside annually to maintain them.

Immigrant rights group sues, says ICE is holding Vietnamese in limbo

Hoang Trinh was 4 years old when he arrived from Vietnam, part of a large Catholic family that fled a war-torn homeland to build a new life together in Garden Grove.

But now the U.S. government wants him to return to Vietnam, despite a 10-year-old agreement between the two countries that dictates who Vietnam will and won't accept back.

The detentions of Vietnamese refugees and other Asian immigrants may easily get lost in the immigration debate, which typically centers on Latinos. But civil rights advocates brought it front and center on Feb. 28 when they announced a class-action lawsuit challenging what they allege are unlawful detentions by the Trump administration.

"This administration is an equal opportunity abuser of people. It's important to highlight that this issue certainly is impacting Asian American communities. ... They are just as vulnerable" as Latino immigrants, said Laboni Hoq, litigation director with Los Angeles office of Asian Americans Advancing Justice, a nonprofit that advocates for Asian-American civil rights.

Specifically, the group says the Trump administration has targeted a handful of Vietnamese refugees who have been in the United States since before 1995 and detaining them indefinitely for deportation.

The lawsuit cites Trinh and three other petitioners among approximately 40 Vietnamese refugees awaiting deportation while housed in immigration detention facilities. Some have been detained over 90 days; some as long as 11 months. And that is illegal, their attorneys say, bedoesn't have the right to hold people indefinitely unless there's an expectation that their country of origin will take them back.

In the case of Vietnam. that country doesn't just refugees, though none are Jerry Brown. take anyone back. And, represented in the suit. traditionally, it hasn't.

There is a 2008 agreement that sets the provisions, conditions and procedures under which a class action. Vietnamese citizen living in the United States can be able through ICE, 71 indirepatriated. The Vietnamese government considers requests on a case-by-case basis. But if the refugees left Vietnam for the United States before July 12, 1995, the date when diplomatic relations were re-established between the two countries, they may not be deported back to their home country.

The Vietnamese currently in immigration detention previously were charged with crimes but all have already served time for those incidents. the lawyers said. Since then, Hoq said, they have "reintegrated into society."

The lawsuit filed in federal court in Santa Ana on Feb. 22 names ICE, Orange County Sheriff Sandra Hutchens and other officials.

A similar lawsuit filed by the same group in October alleges ICE is ordering the deportation of Cambodian refugees, in many cases, for decadesold convictions. More than 100 Cambodian refugees were detained in October, many of them from Long Beach, Modesto and Stockton. Cambodia has accepted an average of 35 individuals for repatriation annually, but the U.S. government is pressuring that country to take more, attorneys said.

Homebuying in Garden Grove in the fourth quarter outpaced Westminster sales activity.





De La Torre is accused of attacking five women within a 1 1/2-mile radius in Anaheim and Garden Grove between about 5:15 p.m. and 9:00 p.m. on Jan. 16, 2014.

Prosecutors said De La Torre tried to engage one woman in conversation as she walked home in Garden Grove and then attacked her and tried to pull down her pants before fleeing.

He then allegedly grabbed another woman as she arrived home, stabbed her in the arm and back, and then fled when her boyfriend walked inside the home.

The third and fourth victims were in an Anaheim hotel when prosecutors said De La Torre attempted to force his way into their room and then stabbed the women as they screamed and struggled.

He is also accused of attacking a fifth woman while she was jogging in Garden Grove.

De La Torre's lawyer, Deputy Public Defender Patricia Bradwell, said he was one of several accomplices participating in a string of burglaries and robberies that day and was arrested in a "rush to provide closure" for the victims.

The women were not attacked with the intent of sexual assault but were being "subdued" during the commission of the burglaries and robberies, she said.

While the women believe they were sexually assaulted, the truth will show otherwise, Bradwell said.

"The problem with this story is that although it represents their truth... it is not the truth," she said.

Garden Grove police shoot, kill wanted man, 31, in Santa Ana

SANTA ANA – A 31-year-old man was shot multiple times and killed by Garden Grove officers in a Santa Ana 7-Eleven parking lot late Friday night, March 2, police said.

Garden Grove police investigators were conducting surveillance on the man, who was wanted on a no-bail warrant for violating the terms of his probation, Garden Grove police Lt. Carl Whitney said.

The officers located the suspect in the parking lot of the 7-Eleven at 1700 E. Dyer Road in Santa Ana.

"Investigators contacted the man in his vehicle in the parking lot, which is when the officer-involved shooting occurred," Whitney said in a news release.

It wasn't clear what happened before the shooting or why the officers shot the man.

After he was shot, investigators and paramedics called to the scene rendered first aid, according to Whitney. The man was taken to a hospital, where he died Saturday at 12:10 a.m.

No officers involved were hurt, Whitney said.

The suspect's name was not released pending notification of his family.

The Orange County District Attorney's Office, along with the Santa Ana Police Department, is conducting an investigation into the shooting.

No additional information was immediately available.




