#### NOTICE OF TREATMENT FOR THE ASIAN CITRUS PSYLLID

On July 21, 2017, the California Department of Food and Agriculture (CDFA) confirmed the presence of the causative bacterial agent of the citrus disease huanglongbing (HLB) from insect vectors collected in the city of Anaheim, Orange County. HLB is a devastating disease of citrus worldwide and is spread through feeding action by populations of the Asian citrus psyllid (ACP), *Diaphorina citri* Kuwayama. In order to determine the extent of the infestation, and to define an appropriate response area, additional survey took place for several days over a one-square mile area, centered on the detection site. The results of this additional survey indicated that the infestation is sufficiently localized to be amenable for effective implementation of the California Department of Food and Agriculture's (CDFA) current ACP and HLB response strategies, which include treatment for ACP.

A Program Environmental Impact Report (PEIR) has been certified which analyzes the ACP and HLB treatment program in accordance with Public Resources Code, Sections 21000 et seq. The PEIR is available at <http://www.cdfa.ca.gov/plant/peir/>. The treatment activities described below are consistent with the PEIR.

In accordance with integrated pest management principles, the CDFA has evaluated possible treatment methods and determined that there are no cultural or biological control methods available to control ACP in this area.

The treatment plan for the ACP infestation will be implemented within a 400 to 800-meter radius of each detection site, as follows:

- Tempo® SC Ultra (cyfluthrin), a contact insecticide for controlling the adults and nymphs of ACP, will be applied from the ground using hydraulic spray equipment to the foliage of host plants; and
- Merit® 2F or CoreTect™ (imidacloprid), a systemic insecticide for controlling the immature life stages of ACP, will be applied to the soil underneath host plants. Merit® 2F is applied from the ground using hydraulic spray equipment, whereas CoreTect™, if used in place of Merit® 2F, is applied by inserting the tablets into the ground and watering the soil beneath the host plants.

#### **Public Notification:**

Residents of affected properties may be invited to a public meeting where officials from CDFA, the Department of Pesticide Regulation, the Office of Environmental Health Hazard Assessment, and the county agricultural commissioner's office will be available to address residents' questions and concerns. Residents are notified in writing at least 48 hours in advance of any treatment in accordance with the Food and Agricultural Code, Section 5779 and 5401-5404. Following the treatment, completion notices are left with the residents detailing precautions to take and post-harvest intervals applicable to the citrus fruit on the property. Treatment information is posted at [http://cdfa.ca.gov/plant/acp/treatment\\_maps.html](http://cdfa.ca.gov/plant/acp/treatment_maps.html).

## FINDINGS REGARDING A TREATMENT PLAN FOR THE ASIAN CITRUS PSYLLID

On July 21, 2017, the California Department of Food and Agriculture (CDFA) confirmed the presence of the causative bacterial agent of the citrus disease huanglongbing (HLB) from insect vectors collected in the city of Anaheim, Orange County. HLB is a devastating disease of citrus worldwide and is spread through feeding action by populations of the Asian citrus psyllid (ACP), *Diaphorina citri* Kuwayama. Based on the survey data, pest biology, information from California's Huanglongbing Task Force, recommendations provided to me by the Department's Primary State Entomologist and Primary State Plant Pathologist, and experience gained from the United States Department of Agriculture's (USDA) control efforts in the southeastern United States, I have determined that an infestation of ACP exists which is infected with the causative agent of HLB.

ACP is an exotic insect that is originally from Asia. It has been introduced into Central and South America, the Caribbean, and Mexico. In the United States, ACP has been found in Alabama, Arizona, Florida, Georgia, Hawaii, Louisiana, Mississippi, South Carolina, Texas, and California (Alameda, Contra Costa, Fresno, Imperial, Kern, Kings, Los Angeles, Madera, Merced, Monterey, Orange, Placer, Riverside, San Benito, San Bernardino, San Diego, San Joaquin, San Luis Obispo, San Mateo, Santa Barbara, Santa Clara, Solano, Stanislaus, Tulare, Ventura, and Yolo counties). ACP feeds on members of the plant family Rutaceae, primarily on *Citrus* and *Murraya* species, but is also known to attack several other genera. The psyllids cause injury to their host plants via the withdrawal of large amounts of sap as they feed and via the production of large amounts of honeydew, which coats the leaves of the tree and encourages the growth of sooty mold, which blocks sunlight from reaching the leaves. However, the most serious damage caused by ACP is due to its vectoring the phloem-inhabiting bacteria in the genus *Candidatus Liberibacter*, the causal agents of HLB. HLB is considered one of the most devastating diseases of citrus in the world, because it causes trees to produce inedible fruit and results in the eventual death of infected trees. Symptoms of HLB include yellow shoots with mottling and chlorosis of the leaves, misshapen fruit, fruit that does not fully color, and fruit that has a very bitter taste making it inedible for human consumption. HLB is in some southeastern U.S. states such as Florida and Texas, as well as in central Mexico.

These pests present a major threat to citrus grown within the State. California is the top citrus-producing state in the U.S., with total production valued at over \$2.2 billion. Additionally, the establishment of ACP in currently uninfested areas of California would increase the need for pesticide use by commercial and residential citrus producers, as well as require enforcement of quarantine restrictions. Recent studies in Florida have shown that the presence of HLB increases citrus production costs by up to 40 percent and has resulted in a loss of over \$7 billion and 6,600 jobs over the last five years. The causative bacteria of HLB has been found in Los Angeles and Orange counties. Infected trees are destroyed when discovered, but the threat of reintroduction continues. Allowing the establishment of ACP in currently uninfested areas of California could pave the way for HLB to spread rapidly. HLB would have severe consequences to both the citrus industry and to the urban landscape via the decline and the death of citrus trees.

This decision to proceed with treatment is based upon a realistic evaluation that it may be possible to address the threat posed by ACP using currently available technology in a manner that is recommended by California's HLB Task Force. In making this decision, the CDFA has evaluated possible treatment methods. In accordance with integrated pest management principles, the following is the list of options that I have considered for the treatment of this ACP infestation: 1) physical controls; 2) cultural controls; 3) biological controls; and 4) chemical controls.

Based upon input from my professional staff, including memorandums from the Primary State Entomologist and Primary State Plant Pathologist, and the input of experts familiar with ACP and HLB, I have concluded that there are no cultural or biological control methods that are effective to treat the ACP that allow the CDFA to meet its statutory obligations. To treat ACP in this area, I am ordering applications of pesticides be made using ground-based equipment to all ACP hosts within an 800-meter radius around the detection site and any subsequent sites. The ACP option selected is a chemical control measure that involves the use of insecticides targeting both the adult and immature stages of ACP. This option was selected based upon biological effectiveness, minimal public intrusiveness, cost, and minimal impacts to the environment.

A Program Environmental Impact Report (PEIR) has been prepared which analyzes the ACP and HLB treatment program in accordance with Public Resources Code (PRC), Sections 21000 et seq. The PEIR was certified in December 2014, and is available at <http://www.cdfa.ca.gov/plant/peir/>. The PEIR addresses the treatment of the ACP and HLB at the program level and provides guidance on future actions against the ACP and HLB. It identifies feasible alternatives and possible mitigation measures to be implemented for individual ACP and HLB treatment activities. The ACP and HLB program has incorporated the mitigation measures and integrated pest management techniques as described in the PEIR. In accordance with PRC Section 21105, this PEIR has been filed with the appropriate local planning agency of all affected cities and counties. No local conditions have been detected which would justify or necessitate preparation of a site specific plan.

#### **Sensitive Areas**

The treatment area has been reviewed by consulting the California Department of Fish and Wildlife's California Natural Diversity Database for threatened or endangered species. The CDFA also consults with the United States Fish and Wildlife Service, the National Marine Fisheries Service and the California Department of Fish and Wildlife when rare and endangered species are located within the treatment area. Mitigation measures will be implemented as needed. The CDFA will not apply pesticides to bodies of water or undeveloped areas of native vegetation. All treatment will be applied to residential properties, common areas within residential development, non-agricultural commercial properties, and right-of-ways.

#### **Work Plan**

The proposed program area encompasses those portions of Orange County which fall within a one-square-mile area around the property on which ACP have been detected, and any subsequent detection sites within the program boundaries. A map of the project boundaries is attached. The work plan consists of the following elements:

1. **ACP Monitoring.** Yellow panel traps will be placed within an 800-meter radius around each HLB detection site to monitor post-treatment ACP populations. Traps will be placed at a density of 100 traps per square mile and will be serviced on a regular schedule, generally once every two weeks.
2. **ACP and HLB Visual Survey.** All host plants will be inspected for ACP and for HLB symptoms within an 800-meter radius around each HLB detection site, at least twice a year. ACPs and HLB-symptomatic plant tissue will be collected and forwarded to the CDFA Plant Pest Diagnostic Center (PPDC) for identification and analysis.

3. HLB Disease testing. All collected symptomatic host tree tissues and ACP life stages will be tested by the PPDC for the presence of HLB.
4. Treatment. All properties with host plants within a 400 to 800-meter radius around each HLB detection site will be treated according to the following protocol to control ACP:
  - a. Tempo® SC Ultra, containing the contact pyrethroid insecticide cyfluthrin, will be applied by ground-based hydraulic spray equipment to the foliage of host plants for controlling the adults and nymphs of ACP. Treatment may be re-applied up to six times annually if additional ACPs are detected.
  - b. Either Merit® 2F or CoreTect™, containing the systemic insecticide imidacloprid, will be applied to the root zone beneath host plants for controlling developing nymphs and providing long term protection against reinfestation. Merit® 2F is applied as a soil drench, while CoreTect™ tablets are inserted two to five inches below the soil surface and watered in to initiate tablet dissolution. CoreTect™ is used in place of Merit® 2F in situations where there are environmental concerns about soil surface runoff of the liquid Merit® 2F formulation, such as host plants growing next to ponds and other environmentally sensitive areas. Treatment may be re-applied once annually if additional ACPs are detected.

#### **Public Information**

Residents of affected properties may be invited to a public meeting where officials from the CDFA, the California Department of Pesticide Regulation, the Office of Environmental Health Hazard Assessment, and the county agricultural commissioner's office will be present to address residents' questions and concerns. Residents are notified in writing at least 48 hours in advance of any treatment in accordance with the Food and Agricultural Code (FAC), Section 5779. After treatment, completion notices are left with the residents detailing precautions to take and post-harvest intervals applicable to the citrus fruit. Information concerning the ACP program will be conveyed directly to local and State political representatives and authorities via letters, emails, and/or faxes. Treatment information is posted at [http://cdfa.ca.gov/plant/acp/treatment\\_maps.html](http://cdfa.ca.gov/plant/acp/treatment_maps.html). Press releases, if issued, are prepared by the CDFA information officer and the county agricultural commissioner, in close coordination with the program leader responsible for treatment. Either the county agricultural commissioner or the public information officer serves as the primary contact to the media.

#### **Duty to Act**

Under my statutory authority, as Secretary of the California Department of Food and Agriculture, I have decided, based upon the likely environmental and economic damage that would be inflicted by an established infestation of HLB in this area, that it is incumbent upon me to attempt to address this threat.

My duty to act, and this decision, is based upon authority set forth in Sections 24.5, 401.5, 403, 407, 408, 5401-5405, and 5761-5764 of the FAC, authorizing and mandating the Secretary to: thoroughly investigate the existence of the pest; determine the probability of the pest spreading to other areas;

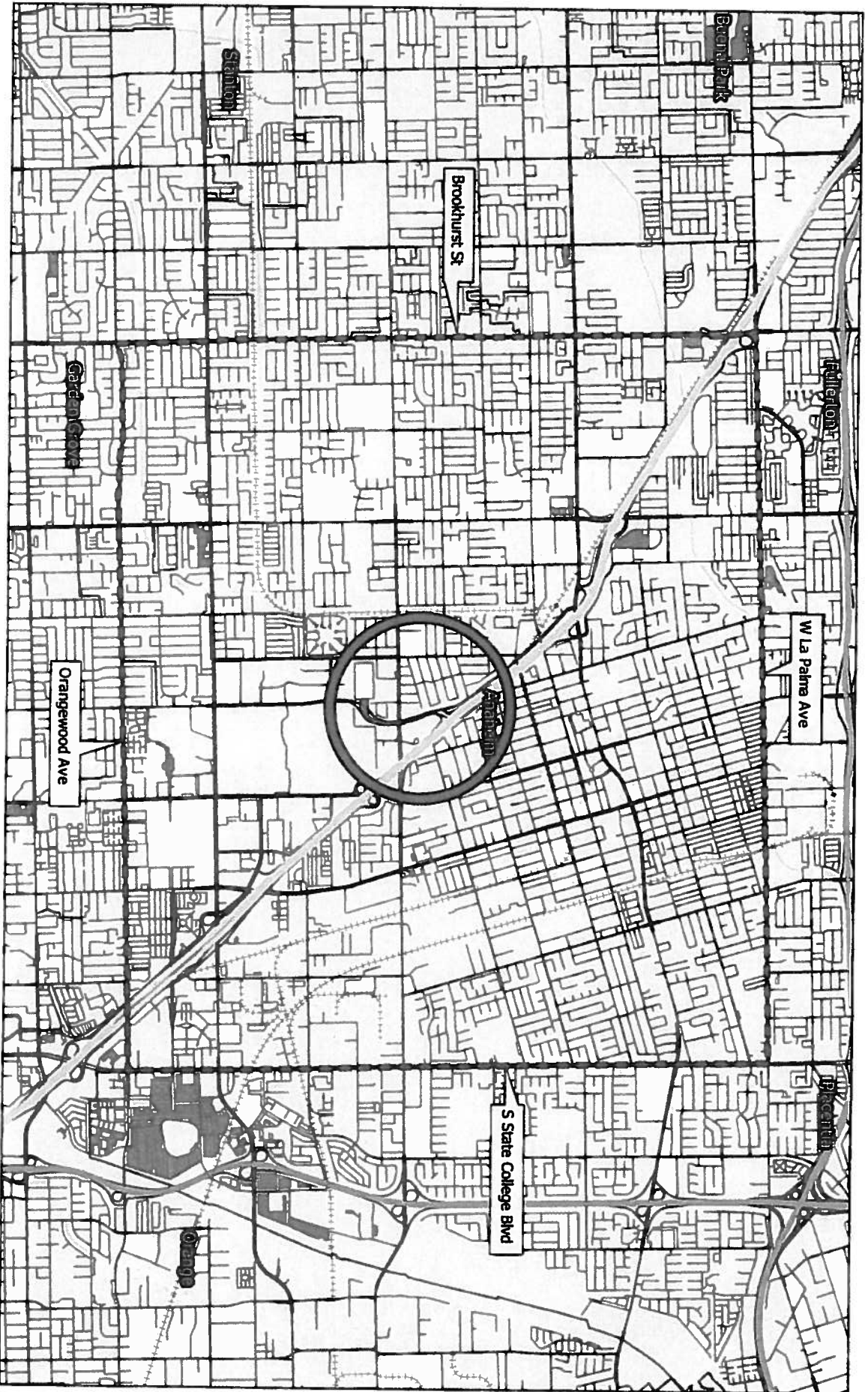

adopt regulations (Title 3 of the California Code of Regulations, Section 3591.21) as are reasonably necessary to carry out the provisions of this code; abate a pest from the established treatment area; and, to prevent further economic damage. **I. Trapping and Visual Survey**

**A. Urban and Rural Residential Detection Trapping and Visual Survey**

This is a cooperative State/County trapping program for the Asian Citrus Psyllid (ACP) to provide early detection of an infestation in a county. Traps are serviced by agricultural inspectors. The trap used for ACP detection is the yellow panel trap, which is a cardboard panel coated with stickum on each side. ACP becomes entangled on the sticky surface and cannot move off of the trap. Yellow panel traps have proven successful at detecting infestations of ACP. At all locations where traps are placed, the host plant is visually inspected for ACP. If ACP is detected, the host will be visually surveyed for additional ACP and symptoms of huanglongbing (HLB).

- Trap Density: Five to 16 traps/square mile.
- Trap Servicing Interval: Every two to four weeks.
- Trap Relocation and Replacement: Traps should be replaced and relocated every four to eight weeks to another host at least 500 feet away, if other hosts are available.
- Visual surveys and/or tap sampling are conducted once at each trapping site when the trap is placed.

**B. Delimitation Trapping and Visual Survey Outside of the Generally Infested Area**

The protocols below are the actions in response to the detection of ACP in counties north of Ventura County and the Tehachapi Mountains.

**1. Response to the collection one or more ACP**

**a. Trapping**

Density will be 25 to 100 traps per square mile in a 1.5 mile radius, to form a nine-square mile delimitation area. Traps will be serviced weekly for one month. If no additional ACP are detected, the traps will be serviced monthly for two years past the identification date. Additional detections may increase the size of the delimitation survey area and will restart the two-year clock on the trap servicing requirement.

**b. Visual Survey**

All find sites and adjacent properties will be visually surveyed for ACP and HLB. Additional sites may be surveyed as part of the risk-based survey.

**C. Commercial Grove Trapping**

In counties with substantial commercial citrus production and are not generally infested with ACP, traps are placed within the groves at the density of one trap per 40 acres. Traps are replaced every month and submitted for screening.

In areas that are generally infested with ACP, agricultural inspectors visually survey commercial groves for plant tissue displaying symptoms of HLB and collect ACP which are tested for HLB.

**II. Treatment**

CDFA's treatment activities for ACP vary throughout the state and depend on multiple factors. Factors CDFA considers prior to treatment include:

- Determination if suppression of ACP is feasible;
  - The proximity of the ACP infestation to commercial citrus;
  - Whether growers are conducting coordinated treatment activities;
  - The level of HLB risk;
  - Consistency with the overall goal of protecting the state's commercial citrus production.
- A. Treatment scenarios throughout the state in which treatment will occur:**
- In areas with commercial citrus production that are generally infested with ACP, and where all growers are treating on a coordinated schedule; CDFA may conduct residential buffer treatments to suppress ACP populations.
  - In areas with commercial citrus production that are not generally infested with ACP; CDFA will conduct residential treatments in response to ACP detections.
  - In areas where HLB is detected, CDFA will conduct residential treatments to suppress ACP populations.
  - In areas where ACP has not been previously detected, or where ACP has been detected at low densities, CDFA will conduct residential treatments to prevent ACP establishment or suppress populations.

CDFA's current policy is to not conduct treatments in areas that are generally infested if there is limited or no commercial citrus production in the area, or if all growers in the area are not treating.

**1. Treatment Protocols**

A Program Environmental Impact Report (PEIR) has been certified which analyzes the ACP treatment program in accordance with Public Resources Code, Sections 21000 et seq. The PEIR is available at <http://www.cdfa.ca.gov/plant/peir>. The treatment activities described below are consistent with the PEIR.

In accordance with the integrated pest management principles, the CDFA has evaluated possible treatment methods and determined that there are no physical, cultural, or biological control available to eliminate ACP from an area.

In general, when treatment has been deemed appropriate, CDFA applies insecticides to host trees in the residential (urban) areas in a 50 to 800-meter radius around each detection site. Only ACP host plants are treated.

- a. Within two miles of International Border with Mexico**
  - CDFA will treat the residential area within an 800-meter buffer of the border.
- b. Within a Generally Infested Area With Commercial Citrus Production**
  - CDFA will treat the residential area within a 400-meter buffer surrounding commercial citrus groves if the growers are conducting coordinated treatments.
  - A Notice of Treatment (NOT) will be issued.
- c. Outside of the Generally Infested Area**

The actions below are in response to the detection of one ACP in counties north of Ventura County and the Tehachapi Mountains.

- Detection of one ACP - All properties with hosts within 50-meter radius of the detection site will be treated.
- A NOT will be issued.

The actions below are in response to the detection of two or ACP in Fresno, Madera, Kern, Kings, and Tulare counties.

- Detection of two or more ACP on one trap or one or more ACP detected on separate traps within 400 meters of each other within a six month period – All properties with hosts within a 400-meter radius will be treated.
- In a commercial citrus environment, where there are few residences in the area, CDFA will treat the residential area within an 800-meter buffer surrounding commercial citrus groves if the growers are conducting coordinated treatments.

**d. In response to an HLB Detection**

- All properties within an 800-meter radius of the detection site will be treated. A NOT will be issued.
- A NOT will be issued.

**2. Treatment Methodology**

The treatment protocol consists of both a foliar and a systemic insecticide. The foliar insecticide is used for immediate reduction of the adult population in order to prevent the adults from dispersal. The systemic insecticide is a soil treatment used to kill the sedentary nymphs and provide long term protection against reinfestation. Treatment frequency is dependent on the insecticide applied and severity of the infestation. Treatments will end no later than two years after the last psyllid detection in the treatment area.

CDFA uses registered pesticides and follows the label directions. The treatment protocol may be adjusted to use only the foliar or the systemic insecticide to allow for mitigations in special situations.

**a. Foliar Treatment**

Tempo® SC Ultra (cyfluthrin) is a pyrethroid contact insecticide. Treatment will initially occur once, and subsequent applications may occur for up to three times annually if additional psyllids are detected. This material will be applied to the foliage of all host plants using hydraulic spray or hand spray equipment.

**b. Soil Treatment**

A systemic soil application will be made using either Merit® 2F or CoreTect™.

- Merit® 2F (imidacloprid), is a neonicotinoid systemic insecticide. Treatment will initially occur once, and a subsequent application may occur once on an annual basis if additional psyllids are detected. This material will be applied to the soil within the root zone of host plants.

- **CoreTect™ (imidacloprid) is a neonicotinoid systemic insecticide. It is used in place of Merit® 2F in situations where there are environmental concerns about soil surface runoff of the liquid Merit® 2F formulation, such as host plants growing next to ponds and other environmentally sensitive areas. Treatment will initially occur once, with a subsequent application once on an annual basis if additional psyllids are detected. This material is a pelletized tablet and is inserted into the soil and watered in within the root zone of host plants.**

**INTEGRATED PEST MANAGEMENT ANALYSIS OF ALTERNATIVE TREATMENT  
METHODS FOR CONTROL OF THE ASIAN CITRUS PSYLLID  
January 2017**

The chemical treatment program used by the California Department of Food and Agriculture (CDFA) for control of the Asian citrus psyllid (ACP), *Diaphorina citri* (Hemiptera: Psyllidae), targets multiple life stages. A contact insecticide is used for an immediate control of adults in order to prevent spread, and a systemic insecticide is used to control developing nymphs and to give the plant long term protection from re-infestation. The contact insecticide preferentially used contains the synthetic pyrethroid cyfluthrin, while the systemic insecticide contains the synthetic neonicotinoid imidacloprid. Both products have been shown to be effective against ACP elsewhere, particularly in Florida. The California Huanglongbing Task Force, a joint government, university, and industry group formed in 2007 to provide guidance to the CDFA on matters pertaining to ACP and huanglongbing has endorsed the use of these chemicals in the CDFA's treatment program.

Below is an evaluation of alternative treatment methods to control ACP which have been considered for treatment programs in California.

**A. PHYSICAL CONTROL**

**Mass Trapping.** Mass trapping of adults involves placing a high density of traps in an area in an attempt to physically remove them before they can reproduce. The current available trapping system for ACP relies on short distance visual stimulus, and is not considered effective enough to use in a mass trapping program.

**Active Psyllid Removal.** Adult ACPs are mobile daytime fliers, and adults could theoretically be netted or collected off of foliage. However, due to their ability to fly when disturbed, and the laborious and time-prohibitive task of collecting minute insects from several properties by hand, it would be highly unlikely that all adults could be captured and removed. Nymphs attach themselves to developing leaves and stems via their proboscis. Therefore, physical removal of the nymphs would entail removal of the growing shoots which will stunt the tree and reduce fruit production. For these reasons, mechanical control is not considered to be an effective alternative.

**Host Removal.** Removal of host plants would involve the large scale destruction of plants and their roots by either physical removal or phytotoxic herbicides. Additionally, host removal could promote dispersal of female psyllids in search of hosts outside of the treatment area, thus spreading the infestation. For these reasons, host removal is considered inefficient and too intrusive to use over the entirety of the treatment areas used for ACP.

**B. CULTURAL CONTROL**

**Cultural Control.** Cultural controls involve the manipulation of cultivation practices to reduce the prevalence of pest populations. These include crop rotation, using pest-resistant varieties, and intercropping with pest-repellent plants. None of these options are applicable for ACP control in an urban environment, and may only serve to drive the psyllids outside the treatment area, thus spreading the infestation.

**C. BIOLOGICAL CONTROL**

**Microorganisms.** No single-celled microorganisms, such as bacteria, are currently available to control ACP.

**Nematodes.** Entomopathogenic nematodes can be effective for control of some soil-inhabiting insects, but are not effective, nor are they used, against above ground insects such as psyllids.

**Parasites and Predators.** There have been two parasites released in Florida against ACP, but only one of these are considered somewhat successful there, namely *Tamarixia radiata* (Hymenoptera: Eulophidae). This insect has been released into the environment in southern California. The CDFA is working with the citrus industry to pursue options for incorporating this parasite into treatment programs statewide. In addition, a second wasp has been recently released by the University of California Riverside, *Diaphorencyrtus aligarhensis*.

**Sterile Insect Technique (SIT).** SIT involves the release of reproductively sterile insects which then mate with the wild population, resulting in the production of infertile eggs. SIT has neither been researched nor developed for ACP, nor has it been developed for any species of psyllids, and is therefore unavailable.

#### D. CHEMICAL CONTROL

**Foliar Treatment.** A number of contact insecticides have been researched for use against ACP elsewhere, particularly in Florida. Contact insecticides are more effective against adult ACPs than the sedentary nymphs because adults actively move around on plants, thereby coming into contact with residues, whereas nymphs have to be directly sprayed in order for them to come into contact. The following product has been identified for use by the CDFA, based on a combination of effectiveness against ACP, worker and environmental safety, and California registration status.

## PEST PROFILE

Common Name: Asian Citrus Psyllid

Scientific Name: *Diaphorina citri* Kuwayama

Order and Family: Hemiptera, Psyllidae

Description: The Asian citrus psyllid (ACP) is 3 to 4 millimeters long with a brown mottled body. The head is light brown. The wings are broadest in the apical half, mottled, and with a dark brown band extending around the periphery of the outer half of the wing. The insect is covered with a whitish waxy secretion, making it appear dusty. Nymphs are generally yellowish orange in color, with large filaments confined to an apical plate of the abdomen. The eggs are approximately 0.3 millimeters long, elongated, and almond-shaped. Fresh eggs are pale in color, then, turn yellow, and finally orange at the time of hatching. Eggs are placed on plant tissue with the long axis vertical to the surface of the plant.

History: Asian citrus psyllid was first found in the United States in Palm Beach County, Florida, in June 1998 in backyard plantings of orange jasmine. By 2001, it had spread to 31 counties in Florida, with much of the spread due to movement of infested nursery plants. In the spring of 2001, Asian citrus psyllid was accidentally introduced into the Rio Grande Valley, Texas on potted nursery stock from Florida. It was subsequently found in Hawaii in 2006, in Alabama, Georgia, Louisiana, Mississippi, and South Carolina in 2008. ACP was first found in California on August 27, 2008 in San Diego County. Subsequent to this initial detection in San Diego County, the ACP has been detected in 25 other California counties (Alameda, Contra Costa, Fresno, Imperial, Kern, Kings, Los Angeles, Madera, Merced, Monterey, Orange, Placer, Riverside, San Benito, San Bernardino, San Joaquin, San Luis Obispo, Santa Barbara, Santa Clara, San Mateo, Solano, Stanislaus, Tulare, Ventura, and Yolo counties). The ACP has demonstrated the potential to establish itself throughout California wherever citrus is grown.

Distribution: ACP is found in tropical and subtropical Asia, Afghanistan, Saudi Arabia, Reunion, Mauritius, parts of South and Central America, Mexico, the Caribbean, and in the U.S. (Alabama, Arizona, California, Florida, Georgia, Hawaii, Louisiana, Mississippi, South Carolina, and Texas).

Life Cycle: Eggs are laid on tips of growing shoots; on and between unfurling leaves. Females may lay more than 800 eggs during their lives. Nymphs pass through five instars. The total life cycle requires from 15 to 47 days, depending on environmental factors such as temperature and season. The adults may live for several months. There is no diapause but populations are low in the winter or during dry periods. There are nine to ten generations a year, with up to 16 noted under observation in field cages.

Hosts and Economic Importance: ACP feeds mainly on *Citrus* spp., at least two species of *Murraya*, and at least three other genera, all in the family Rutaceae. Damage from the psyllids occurs in two ways: the first by drawing out of large amounts of sap from the plant as they feed and, secondly, the psyllids produce copious amounts of honeydew. The honeydew then coats the leaves of the tree, encouraging sooty mold to grow which blocks sunlight to the leaves. However, the most serious damage caused by ACP is due to its ability to effectively vector three phloem-inhabiting bacteria in the genus *Candidatus* Liberibacter, the most widespread being *Candidatus* Liberibacter asiaticus. These bacteria cause a disease known as huanglongbing, or

citrus greening. In the past, these bacteria have been difficult to detect and characterize. In recent years, however, DNA probes, electron microscopy, and enzyme-linked immunosorbent assay tests (ELISA) have been developed that have improved detection. Symptoms of huanglongbing include yellow shoots, with mottling and chlorosis of the leaves. The juice of the infected fruit has a bitter taste. Fruit does not color properly, hence the term "greening" is sometimes used in reference to the disease. Huanglongbing is one of the most devastating diseases of citrus in the world. Once infected, there is no cure for disease and infected trees will die within ten years. The once flourishing citrus industry in India is slowly being wiped out by dieback. This dieback has multiple causes, but the major reason is due to HLB. In California, the disease has only been found in residential areas of Los Angeles and Orange counties.

Debbi Ebert brings her A-game to Garden Grove's Gem Theater

One More Productions presented its first-ever Summer Cabaret series at Garden Grove's intimate Gem Theatre, and "Divalicious" An Evening with Debbi Ebert brought an elated crowd to its feet.

Ebert's incomparable two-act "Celebration of Women in Jazz" featured rarely-performed songs from her latest CD in Act I, while Act II was a true and honest celebration of legendary jazz songstress Miss Nancy Wilson.

Setting the stage for what was about to come, Ebert opened with "Can You Read My Mind," and in her relaxed, sultry style, the audience felt the joy in Ebert's heart from the first notes she sang. She then moved into the Latin number, "Rio De Janeiro Blue," and its soft Bossa Nova beat had the audience swaying and grooving along with the pulsating rhythms.

Ebert's vocal expressions were as silky and smooth as the azure Brazilian coastline. Her unique arrangement of the well-known song, "At Last," simply with saxophone and upright bass accompaniment, featured Nic

Gonzalez's harmonic chord progression on bass and was a perfect example of Ebert's creativity and her imaginative approach to interpreting a song. Another illustration of her innovative musical ideas was evident in her wonderfully surprising "mash up" of the Sammy Cahn and Jule Styne's jazz standard "Time After Time" along with Cyndy Lauper's popular song of the same name.

With a nod to Debbi's friend and American soul cellist Fred Katz, Ebert sang "I Just Want to Get to Know You" as the spotlight shone on special-guest artist Renda Pettis, who performed an expressive interpretive dance.

"What a Wonderful World" brought oohs and ahhs from the audience as Ebert talked about Louis Armstrong. She referred to him as Pops, and it was though Satchmo himself was the theater that night as Richard Ibara came out of the shadows with a voice that replicated the late great Armstrong as well as any simulation I've ever heard.

In abstract and literal ways, Miss Ebert's song choices formed a narrative of love and life in contemporary times as well as times gone by.

From "(You Don't Know) How Glad I Am," to "A Lady With a Song," Ebert captured the sound and the soul of the great Nancy Wilson that evening.

# Rare summer storm hits region

Pea-sized hail, thunder and lightning reported in northern part of county

Showers descended on Orange County on Tuesday afternoon, bringing strong winds and thunder to some areas and ousting people from the U.S. Open of Surfing in Huntington Beach.

At 4:32 p.m., the National Weather Service issued a warning: "Doppler radar was tracking a thunderstorm near Santa Ana moving west at 10 mph. Pea-size hail, lightning and winds in excess of 35 mph will be possible with this storm. There is a slight chance for a lightning strike near Huntington or Seal Beach."

The affected cities were Anaheim, Buena Park, Costa Mesa, Garden Grove, Huntington Beach, Irvine, Newport Beach, Orange, Santa Ana, Seal Beach, Tustin and Westminster. The rain followed the combination of high heat — around 90 degrees in Anaheim — and more than 50 percent humidity.

Along the coast, forecasters warned of rougher waters. A beach hazard statement was in effect for elevated surf and strong rip currents through Tuesday evening, according to the National Weather Service. South swells were set to produce surf as high as 6-7 feet in south Orange County and north San Diego County.

The beaches in Huntington Beach were closed Tuesday afternoon, the Police Department said. The city is hosting the U.S. Open of Surfing, and officials said they were evacuating the event activities, which were mostly over by the time the rain began.

Tens of thousands of beachgoers had to leave Huntington after lightning threats prompted lifeguards to evacuate the sand and surf — though with a big swell, there were plenty

of surfers who ignored warnings to keep taking waves. The beach was reopened just before 6 p.m., but the surfing events were already done for the day.

Huntington Beach Marine Safety Lt. Eric Dieterman said lifeguards had been tracking the storm.

"It was a busy day; we had quite a large crowd for

the event," he said, estimating that there were between 50,000 and 70,000 people on the sand.

"As soon as people start to see lightning, they start to come to shore."

Isolated thunderstorms were predicted until this evening. The clouds and rain are expected to be gone by Thursday morning.

When Jared Watson and Dustin Bushnell of the Dirty Heads and Rome Ramirez of Sublime With Rome get together, magic seems to happen.

The trio have known each other for well over a decade and have collaborated regularly and successfully throughout that time. Back in 2010, Dirty Heads released the cut “Lay Me Down,” featuring Ramirez on vocals, and it helped launch the Huntington Beach-based quintet into the mainstream, with the song landing in the No. 1 spot on Billboard’s alternative and rock songs charts.

That particular track came together one night during an impromptu jam session as the guys were hanging out and enjoying a few cold Coronas in the backyard of Bushnell’s Orange County home.

“His daughter was in the background crying the entire time,” Ramirez recalled with a laugh. “We were like, ‘This song may not be that good if it’s making kids cry.’”

The relationship goes far beyond just one song, as Ramirez has served as a producer on several Dirty Heads albums, including their forthcoming seventh release, “Swim Team,” due in the fall.

As they were putting the finishing touches on the record in a Costa Mesa studio last month, they were also working out the details for the Dirty Heads/Sublime With Rome-curated High & Mighty festival.

In partnership with local festival promoters Synergy Global Entertainment (Ozzfest/Knotfest, Driftwood, Sabroso, Ohana) and Bill Hardie (Musink Tattoo Convention & Music Festival), the two-day event will take place Saturday and Aug. 6 at Village Green Park at Main and Euclid streets in downtown Garden Grove. The fest was initially scheduled to take place at Oak Canyon Park in Silverado but was moved to the more spacious location in June.

Saturday will be headlined by Sublime With Rome with Soja, Stick Figure, Magic!, King Lil G, Katastro, Iya Terra, Tunnel Vision, Tyrone's Jacket and NoahJvmes. Dirty Heads headline Aug. 6 with Jurassic 5, Tribal Seeds, Tech N9ne, Chief Keef, Murs, Ballyhoo!, Pacific Dub, Landon McNamara and Know-Madik.

The all-ages fest will start around 1 p.m. each day and end at 10 p.m. Saturday and 9 p.m. Aug. 6. There will also be carnival rides and games, a vendor village, local eats and craft beer tastings courtesy of Brew Ha Ha Productions from breweries such as Bootleggers, Hangar 24, Green Flash, Modern Fines and more for those 21 or older until 4 p.m.

"We weren't sitting around thinking that we knew how to throw a festival," Watson said. "We knew we had to partner with people who knew what they were doing and who we could trust to see our vision. We knew we wanted bands that we were either inspired by coming up, bands that were inspiring us now and just bands that we've become friends with that are just great people and we knew we were going to crush."

Putting together a day of hip-hop, roots reggae and rock music was something Watson said he's wanted to see in his home county for a long time.

"The whole point of festivals, for me, is to maybe see something new," he said, noting that Dirty Heads have been the odd man out at plenty of festivals, though the exposure has given them the opportunity to win over countless new fans.

"We could have easily done a reggae rock fest and everyone would have known every band, but what's the fun in that? There's a lane for that already here, so we wanted to do something different."

Ramirez said it was essential to get up-and-coming acts such as Chicago-based rapper and producer Chief Keef at the same festival as influential Los Angeles hip-hop group Jurassic 5, but his major concern was the quality of food that would be served to the masses.

"I wanted good food, like quality food, not just (gross) festival food," he said. "That was honestly one of my first concerns. There needs to be some barbecue and tacos all around. I have a very small palate, so I eat the same (stuff) and a lot of it. So if people come out and they're maybe not super into our music, if you don't smoke weed or like hip-hop or reggae, well then come, at least eat some good food."

After finishing up work on Dirty Heads' album, Ramirez and the rest of Sublime With Rome (bassist Eric Wilson and drummer Carlos Verdugo) have been out on tour with fellow Orange County act the Offspring. The pair played one of the last shows at Irvine Meadows Amphitheatre in October and decided then to take the show across the country and overseas this year.

"I finally got to watch the Offspring play at the Irvine Meadows Amphitheatre and it was the first time in a long time," Ramirez said. "I forgot how many insanely awesome songs those guys have. They have like 30 No. 1 hits. I knew the entire set, and so did everyone else. It was kind of an obvious thing for us to go on tour, they were just a different style of band. ... We've been on the road with Pennywise, but that's a little faster punk, but the Offspring has these huge chants and huge melodies and Dexter is an insanely good singer. It's definitely one of those tours where we know we need to bring our A-game because they're going to bring it."

The band is also going to begin work on the follow-up to its 2015 release, "Sirens," this year. With drummer Josh Freese, also of the Vandals, out on tour with Sting, the guys brought in Verdugo, who had previously played with Tribal Seeds.

"That was like a no-brainer," Ramirez said. "Josh wanted to go play with Sting on his private jets. I'm kidding, it's all love, but we jammed with Carlos and it felt really good and super fluid so while Josh is out this summer, Carlos will be jamming with us."

Ramirez joked that the new music would be some sort of "Jimmy Buffett dub-step" but with his eclectic taste, it wouldn't be shocking if he actually pulled something like that off.

"We're going to Texas in October to put together some ideas, but I don't really know what it will be like," he said. "Every album is different because people are listening to different (stuff). If you put out the same album, that's boring. You can't look at yourself in the mirror in the morning and say your album is dope. No, you put out the same album. I'm constantly listening to new music and so are Eric and Carlos, so you've got three different minds coming to-

gether so we'll make sense it all later this year."

Dirty Heads offered a taste of its new music with the upbeat track "Vacation" which was released this month.

The accompanying video features actor Denzel Washington reprising his role as Mr. Belding, the principal of Bayside High School from the hit '80s-'90s TV series "Saved by the Bell."

"We didn't go in with a real direction for this album," Watson said. "Following a single never works. I just went in wanting to have a good time and all of this new, creative and cool stuff started happening and that kind of directed where the album is now."

Not wanting to give up much away about the new release, Watson said the band will be playing some of the new stuff at High & Mighty. Recently it's been incorporating a handful of new songs into its sets to see how they go over in front of an audience.

"That's how I gauge

# Riverside suspect may be tied to string of O.C. robberies

time, believe the suspect is the so-called Fast Food Bandit and who has hit two restaurants in the city: a robbery Thursday at a Carl's Jr. that sparked the chase, and a robbery July 20 at a nearby Pizza Hut.

"Both have similar circumstances in that he passed a note, brandished a firearm, was handed money and he left," said Riverside police Officer Ryan Railsback.

The suspect in many of the Orange County robberies had similar details.

The Riverside pursuit on Thursday afternoon was triggered by a report of a robbery at a Carl's Jr. near Magnolia Avenue and Ross Street.

The robber drove off with a second man, but witnesses were able to give 911 dispatchers a description of the getaway car, police said. A few minutes later, an officer spotted the speeding vehicle near Indiana Avenue and Jefferson Street.

Police pulled the vehicle over, but the driver accelerated away with the officer in pursuit, Riverside police said.

The chase eventually reached the Mission Grove neighborhood, where the driver lost control on a dead end street, sending the vehicle into a gully, where it caught fire, police said.

The driver ran but was quickly apprehended. He suffered minor injuries and was transported to Riverside Community Hospital.

He was arrested but police will not release his name until Garden Grove police can wrap up their probe into the possible connection.

"We don't want to taint their investigation by putting the suspect's mug shot out there," Railsback said. "Garden Grove has the most robberies and they have a lot more witnesses to interview."

The second man involved in the pursuit is still being sought, police said.

The Fast Food Bandit has hit at least 20 eateries in Orange County in July alone, according to law enforcement officials.

The day before the Riverside heists, the thief wanted by Orange County law enforcement hit two fast food restaurants within 20 minutes in different cities, officials said.

Santa Ana police have released images from a robbery of a Jack in the Box at Harbor Boulevard and Hazard Avenue. In that robbery, which took

## Cities stunned by sudden loss of Amanda Jensen

WM city clerk, GG resident was  
beloved in communities

The cities of Westminster and Garden Grove continue grieving the loss of Amanda Jensen, who was shot to death by her boyfriend in his Seal Beach apartment last week, authorities said.

Jensen, 37 and a mother of three, was the city clerk for Westminster and a resident of Garden Grove.

"I'm very, very saddened about Amanda's death," said Westminster City Councilwoman Margie Rice. "It's very personal to me. She was

my friend. We worked together for 11 years. She was always smiling and always ready to help anyone. When I got the news, I just kind of fell apart, to tell the truth, because she was such a fine young lady. It's a great loss to the city, a great loss to the families. My heart just breaks for her parents and her."

The Westminster City Council opened its meeting last week by remembering Jensen.

"The last council meeting was really emotional," said Mayor Tri Ta. "This is a big loss for our city. She was a wonderful person, she was caring, and she was professional."

"She always had a smile on her face," said Rose Robbins, a Garden Grove resident who used to see Jensen around town. "She was so lively. I'm speechless."

Police stated that Jensen was killed by Los Alamitos Police Captain Rick Moore, 49, while visit-

ing him at his apartment in Seal Beach.

Neighbors around 7th Street and Central Avenue reported hearing arguing. At one point, a witness heard Jensen say, "No, don't do this!"

Jensen called 911, but the line went dead.

Neighbors heard gunshots.

A SWAT team — with the help of Westminster police and other agencies — surrounded the complex for hours in what was considered a "barricade situation." Eventually, they went in, and found two dead bodies.

Authorities say Moore killed himself after shooting Jensen three times.

Investigators said Jensen and Moore had a volatile relationship.

Police were called to Jensen's Garden Grove home three times from September, 2016 to June 3 of this year, each time for domestic disputes. Twice, Jensen told police that Moore had struck her. The June 3 incident was investigated

by the DA.

It turned into a "She said, he said" case, authorities said, and there was not enough evidence to pursue charges.

About a year earlier, the DA investigated after Westminster police received an anonymous letter asking them to investigate Moore for domestic abuse.

The DA interviewed Moore and Jensen. Jensen stated that Moore had never assaulted her, authorities said.

Amanda Jensen called being city clerk a "dream job."

She worked at Westminster City Hall for 11 years. In her off time, she was a troop leader for the Girl Scouts of Orange County and served as event chair for the American Cancer Society's Relay for Life event in Garden Grove.

Friends and family have set up a GoFundMe page for Jensen's children ([www.gofundme.com/amanda-jensen](http://www.gofundme.com/amanda-jensen)).

On the page, they state, "A terrible tragedy has hit the family of Amanda Jensen as her life was so abruptly taken. She was a loving mother leaving behind three amazing children Dylan, Hannah and Emma. She had a huge heart, a strong spirit, and a smile and laugh that could light a room. Devoted to her job and family, she will be missed beyond words could describe. This tragedy has hit the children, her family, friends and the community hard. Due to the overwhelming support of community this page was created on behalf of her and in support of her children. We appreciate the support of everyone. All funds are to go to children and in their support for living expenses, college, medical bills, and overall future. Funeral services will be posted at a later time."



## **Proposed Regulations a Detriment to Local Governments Seeking Mandate Reimbursement**

## **Bureau of Cannabis Control Announces it will Likely Withdraw Proposed Medical Cannabis Regulations**

*Cannabis Licensing Authorities Developing New Proposed Regulations for Commercial Medicinal and Adult Use Cannabis Industries*

This spring, the Department of Consumer Affairs' Bureau of Cannabis Control, Department of Public Health and Department of Food and Agriculture released proposed regulations for the Medical Cannabis Regulation and Safety Act. These licensing authorities held public hearings and accepted written comments regarding the proposed regulations. However, in late June, the Legislature passed and Gov. Jerry Brown signed into law, the Medicinal and Adult-Use Cannabis Regulation and Safety Act, which creates one regulatory system for both medicinal and adult-use cannabis. As a result, the licensing authorities will withdraw the proposed medical cannabis regulations noticed for public comment on April 28 and May 5, 2017. The withdrawal is likely to happen early next month. *For more, see Page 3.*

This measure increases the maximum permissible fine amounts for violations or infractions of local ordinances and local building and safety codes, and offers additional tools to recover costs associated with ongoing nuisances.

Local ordinances and building and safety codes reflect policies adopted by communities to establish standards, resolve issues, maintain public and private property and protect public health and safety. There must be adequate enforcement mechanisms for these laws to be effective. Appropriate fines need to be high enough to encourage compliance, while avoiding being overly burdensome or disproportionate for the unaware or first offenders. More severe penalties should be reserved for those that violate repeatedly. The updated maximum fines in AB 345 strike this balance.

Inadequate penalties can erode respect for the law. If the consequences for violation are minimal some community members will ignore the law and create inequities in its application. For example, if an ordinance requires dry brush to be cleared for fire protection but a property owner chooses not to do so, they could be placing the neighboring homes and properties at risk. If one property owner allows trash and junk to build up on their property, it could attract vermin and devalue adjacent properties.

Despite hearings and findings of owners being in violation of local ordinances, some property owners continue to ignore the imposition of fines by the city. AB 345 will allow cities to recover fines through a lien against the property on which the nuisance is present. This change will decrease the burden to both property owners and cities in the process of fine and cost recovery.

AB 345 takes a measured approach. Property owners will continue to be afforded due process such as notification and opportunities to be heard and challenge evidence. Additionally, cities that impose higher penalties will develop a hardship waiver to reduce the amount of the fine if the fine would impose an undue financial burden. With these provisions in place, cities can work to ensure the fines encourage compliance while avoiding undue burdens for individual property owners.

AB 345 is awaiting a vote on the Senate Floor. Cities are encouraged to review and support this measure. Local governments in recent years have faced a series of mandate deferrals, suspensions, and modifications at the state level. In concert with this trend, the commission is proposing new regulations which will create even more barriers for local agencies seeking to obtain reimbursement for mandated services.

Notably, the proposed regulations amend the filing period requirements for reimbursement claims, making the requirements much more difficult for local governments to meet. Under the proposed regulations, test claims must be filed within 365 days of incurring increased costs, regardless of where it lands in the fiscal year. Currently, the submission deadline is by June 30 of the fiscal year following the fiscal year in which increased costs were first incurred. The proposed change hinders a local government's ability to adequately track associated costs and submit accurate claims. The League and other local government organizations are requesting that the commission retain current filing period requirements.

The proposed regulations also contain concerning modifications as they relate to the standard of evidence required for test claims as well as the joint test claim single representative requirement.

The written comments submitted jointly by the League, CSAC and CSDA contain additional details.

The commission considered the proposed regulations at a public hearing today, July 28 at 10 a.m. (Item 6 on the [hearing agenda](#)). Representatives from the local government coalition will be there to testify. League members will be kept apprised of updates on this matter.

The three cannabis licensing authorities are each developing new proposed regulations based on the new law for the commercial medicinal and adult-use cannabis industries. During this process, the licensing authorities will consider the robust and valuable public comment received regarding the proposed medical cannabis regulations.

The licensing authorities will use the emergency rulemaking process for the new proposed regulations. The emergency regulations are expected to be published in fall 2017. The implementation date for the issuance of commercial cannabis licenses remains the same: Jan. 2, 2018.

**Conference Sessions**

Each year the Annual Conference Planning Committee carefully reviews over 100 session proposals and selects those that are most relevant and informative to today's California city official. **SB 1: A Funding Fix for California's Roads**

Senate Bill 1 (Beall) represents landmark infrastructure investment in transportation unseen in a generation. Over the next 10 years, the package will generate \$52 billion to repair the state and local transportation network as well as make investments in key transportation programs such as transit, trade corridors, and active transportation. As the money starts to roll out, cities will see significant increases for the local transportation budgets. Listen to the state's key experts on what SB 1 means for your city and what key provisions to keep in mind to ensure your city's compliance with the new law.

**CalPERS: Our Shared Path to a Sustainable System**

Every four years, CalPERS (California Public Employees' Retirement System) conducts a 50-year look ahead at long term investment market trends. This session will be a review of the CalPERS Asset Liability Management Process. Discussions focus on actuarial assumptions (birth and death rates), macro-economic data, hire/fire rates for the public sector, and numerous other factors that are used to guide the pension system forward. This process could result in significant



changes to the CalPERS asset allocation, assumed rates of return, and ultimately in changes to employer and employee contribution rates.

#### **Prop. 64 Grants: Adult Use of Marijuana Act**

The Board of State and Community Corrections receives an allocation of state excise tax to be distributed to local governments in the form of grants addressing public health and public safety needs associated with Proposition 64 implementation. This panel discusses how local governments can craft a competitive bid for grant monies to assist local agencies in enforcement action related to licensed activities under the law, emergency response related to indoor cultivation and manufacturing activities, as well as marijuana-impaired activities that pose a threat to public safety.

## **League-Sponsored Bond Agency Issues \$9 Million in Tax-Exempt Bonds for Affordable Housing in Dinuba**

### **About Sierra Village Apartments**

Sierra Village Apartments is the new construction of 44 affordable housing units by Self-Help Enterprises. The benefits of the project for the city of Dinuba and Tulare County include the following:

- 100 percent of the affordable rental housing units will be rent restricted for low-income tenants;
- The project consists of 22 two-bedroom units and 22 three-bedroom units; and
- More than 75 percent of the units will be restricted to households earning 50 percent or less of the area median income.

CSCDA and Self-Help Enterprises partnered with Wells Fargo Bank and Jones Hall, P.C. to provide \$9,010,646 in tax-exempt multi-family affordable housing bonds for the project. The financing for the project requires the affordability of units for low-income tenants to be maintained for 55 years.

It was created by cities and counties for cities and counties.
