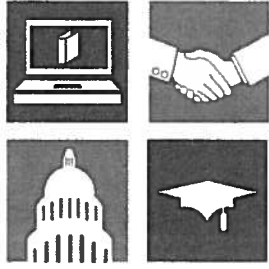

## **SOUTHERN CALIFORNIA EDISON COMPANY'S NOTICE OF APPLICATION FILING REQUESTING TO INCREASE RATES FOR GREEN ENERGY PROGRAMS**

### **A.18-09-015**

#### **Summary**

On September 26, 2018, Southern California Edison Company (SCE) filed Application (A.) 18-09-015 with the California Public Utilities Commission (CPUC) requesting approval to increase rates for its Green Energy Programs (Green Energy Programs). SCE is requesting to increase rates by up to \$5.875 million to recover costs associated with the Green Energy Programs, beginning in 2020. SCE also is seeking authority to offer a discount on the cost of participating in an eligible Green Energy Program for qualifying participants. This discount is estimated to cost \$7.329 million through 2030. If approved, the Green Energy Programs will offer a variety of options for customers to purchase renewable energy resources to meet their electricity needs. SCE designed the Green Energy Programs to give customers clean energy options, support California's clean energy and greenhouse gas (GHG) emission reduction goals, and provide customers with affordable access.

#### **Rate Impact of SCE's Application**

If the CPUC approves SCE's application as proposed, an average non-CARE residential customer using 550 kWh per month could see a monthly bill increase of 0.02%, from a current monthly bill of \$111.32 to \$111.34. The following table compares SCE's current bundled average generation rates, by customer group, to proposed bundled average generation rates in 2019 if SCE's application is approved by the CPUC:

### **CPUC Process**

The application will be assigned to one or more Administrative Law Judges (Judges) who will determine how to receive evidence and other related documents necessary for the CPUC to establish a record upon which to base its decision. Evidentiary Hearings (EHs) may be held where parties of record will present their testimony and may be subject to cross-examination by other parties. These EHs are open to the public, but only those who are parties of record can participate.

After considering all proposals and evidence presented during the formal hearing process Judges will issue a proposed decision which may adopt SCE's application as proposed, modify it, or deny it. Any CPUC Commissioner may sponsor an alternate decision. The proposed decision, and any alternate decisions, will be discussed and voted upon at a scheduled CPUC Voting Meeting.

The Public Advocates Office (Cal PA, formerly Office of Ratepayer Advocates (ORA)) may review this application on behalf of SCE's customers. Cal PA is the independent consumer advocate within the CPUC with a legislative mandate to represent investor-owned utility residential and small commercial customers to obtain the lowest possible rate for service consistent with reliable and safe service levels. Cal PA has a multi-disciplinary staff with expertise in economics, finance, accounting, and engineering. 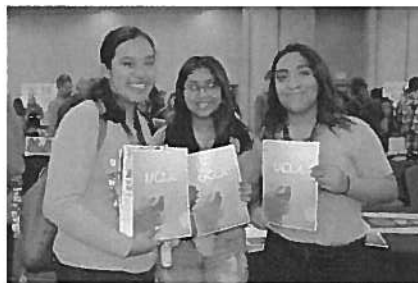



Teasing is a part of growing up. Almost everyone experiences it. However, it becomes bullying when it's repetitive, or when there's a conscious intent to hurt another person. Bullying is not acceptable, no matter what age it happens at.

Victims of **#bullying** are often shy and tend to be physically weaker than their peers. They may also have low self-esteem and poor social skills, which makes it hard for them to stand up for themselves.

Know the signs:

- \* Increased passivity or withdrawal.
- \* Unexplainable injuries.
- \* Lost or destroyed belongings.
- \* Frequent headaches, stomachaches or faking illness.
- \* Changes in eating habits.
- \* Frequent nightmares.
- \* Declining grades/loss of interest in school.
- \* Decreased self-esteem or feelings of helplessness.
- \* Self-destructive behaviors such as running away from home, talk of suicide or harming themselves.

Tips on preventing bullying:

- \* Help kids understand what bullying is; how to stand up to it safely and how to get help.
- \* Keep the lines of communication open by checking with kids often, know their friends, ask about school and listen to their concerns.
- \* Role-play situations to teach your child ways to respond.
- \* Model how to treat others with kindness and respect.

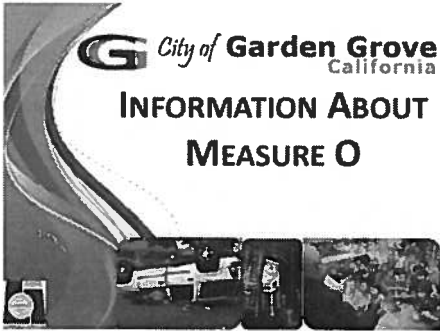

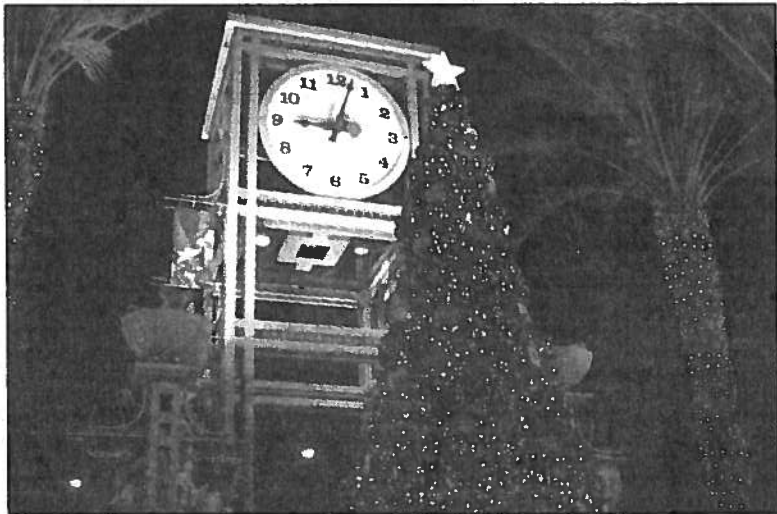
## City to hold Winter in the Grove on Dec. 1

## The Red Car's ghost is still rolling

As the wheels grind toward coming up with a concept for development of the Willowwick Golf Course site (owned by the City of Garden Grove but within Santa Ana city limits) you can also hear the faint rumble of a railroad track.

(<https://orangecountytribune.files.wordpress.com/2018/01/usually-reliable-sources-e1527735160254.jpg>) At Tuesday's "Envision Willowwick" workshop at the Buena Park Youth and Family Center in Garden Grove (suggested mightily by The Tribune), the SWA group – which is in charge of helping to offer and spark ideas for the future use of the 101.5-acre site, opened with an emphasis on "taking inspiration from the historic Red Car town."



The Red Car line – as you may know – ran from Los Angeles southeast down through Orange County – from the early part of the 1900s through mid-century. A passenger and freight line, it transformed Garden Grove from a sleepy village into a busy agricultural town, as well as fired the growth of Santa Ana as the “downtown” of the OC.

So what’s the connection? A railroad-themed development with “neo-traditional” building design? Or perhaps some emphasis on the planned – but not yet promised – stop along the old P.E. (that is, Red Car) right-of-way for the OC Streetcar scheduled to begin construction later this year.

The streetcar would be a way for tourists (and residents) to connect from central Santa Ana – in one direction – and the hotel row on Harbor Boulevard in Garden Grove – from the other to Willowick.

## **The Garden Grove connection**

There’s a fair amount of “so what?” coming from some in the City of Youth and Ambition about the streetcar and Willowick’s future. Here are some reasons why it’s significant.

1. The OC Streetcar could be just the “starter” section of a countywide light rail system.
2. Many of the folks who work in the Harbor hotels live in Santa Ana, so the streetcar is likely to have strong ridership fairly quickly, as it connects to bus routes along that street.
3. Some people think that Willowick is nowhere near Garden Grove; some – on social media – even think it’s in Orange. One reason for the confusion is that the address for Willowick is on 5th Street, but northern edge of the property is the P.E. right-of-way, mere feet from Garden Grove’s southern city limits. Put another way, if you are in that area, it would take you about two minutes to cross from one city to the next. If you walk slow.
4. Disneyland (and its various expansions) has grown beyond its original dimensions. Directly north of Willowick is a large mobile home park located in Garden Grove. Developers are already starting to snap up such parks for more profitable (for them) uses. A successful Willowick project could easily expand across city limits into the GG.

# “Producers”: one for the “cooked” books

It gives new meaning to the old adage, “It’s so bad, it’s good.”

“The Producers” recently had its opening gala at Garden Grove’s Gem Theater (with a rousing introduction by One More Productions co-founder, director and star-at-large Nicole Cassesso) – and out of the gate, looks to be another in a long line of stellar shows by the local troupe.

OMP Director and co-founder Damien Lorton takes a rare turn upon the stage, starring as Max Bialystock, the former “King of Broadway” who’s newest production “Funny Boy” has crashed and burned, having opened and closed the same night amidst an abysmal audience response. It’s the latest in a series of big-budget flops for the producer, who

longs for the heady days of his successes, when he didn't have to wrangle financial backing by acting as role-play boy-toy for little old ladies of means.

But along comes neurotic accountant Leo Bloom (Alex Bodrero) to audit Max's books – also confiding that he's been a fan of the producer's work since he was a boy, and has dreams of being a producer himself. Leo also stumbles across an interesting detail in his audit: that under certain circumstances, more profit could be made from a Broadway flop than a successful show ...

And so the wheels start turning, in Max's greedy little mind ...

But those right conditions must be fulfilled: find the worst director, the worst actors, and of course, the worst play – one that will universally offend all audiences. After an exhaustive search, the duo find it in the form of "Springtime For Hitler," courtesy of Third Reich superfan Franz Liebkind (Chris Harper): the two then approach the flamboyant director Roger De Bris (Robert Edward) and his partner Carmen Ghia (Peter Crisafulli), who initially decline because the show isn't "gay" enough – but are soon persuaded by the potential of a Tony award.

Finally, the show's ingénue appears in the voluptuous form of Swedish actress and bombshell Ulla (Claire Perry) who auditions for the smitten pair, who give her the position of secretary/receptionist: while Max begins working his randy spinster investors to raise capitol for themselves ... Er, for the show, that is.

The pieces are in place, the show is coming together, and nothing can go wrong – or right, as it were...

Those regulars to the Gem Theater's offerings know the level of quality of the productions staged by the OMP troupe, but this is very possibly their finest (and funniest) of the year (two alumni of one of the Gem's raucous comedies this year, "Bullets Over Broadway" figure prominently in "Producers," in fact.) The choreography will have the audience enraptured ... keep an eye out for the walkers, you'll know it when you see it: and the live orchestra overshadows the show, literally – placed on a platform directly above the stage action, even sometimes interacting with the ensemble.

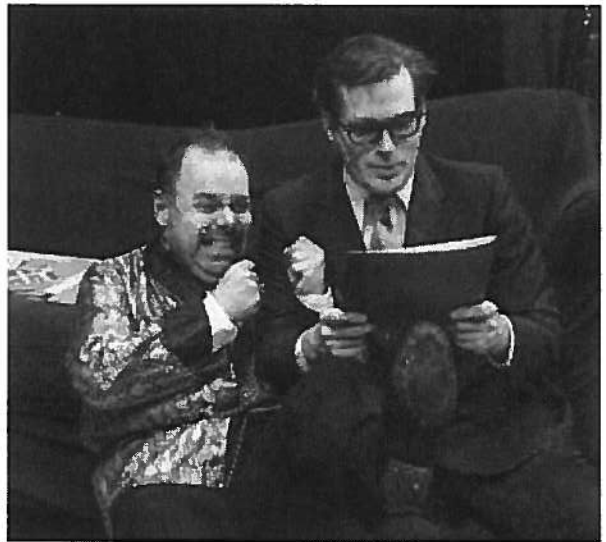
Every single player, from Harper's comic Nazi sympathizer-turned-spirited playwright Franz, to Perry's playful, seductive, yet vaguely innocent Ulla, to Edward and Crisafulli's precocious De Bris and Ghia – whose characters could be over-the-top caricature, yet come across as lovely, engaging, and passionate about their art – inhabit and breathe comic authenticity into their roles ... But it's Bodrero and Lorton who truly knock it out of the park. Bodrero's Leo Bloom has vague shades of his recent neurotic "Bullets" scribe, but is considerably more fully realized – with his errant dreams of being a Broadway producer that his new friend and partner inspires him to grab and make his own. Tunes like "I Wanna Be A Producer." "We Can Do It" and "That Face" showcase both his acting and considerable vocal talents.

★★★★  
Great!

Lorton though ... absolutely owns the role of Max Bialystock. After seeing this show, some audience members might ask themselves why they so rarely see him upon the stage, versus behind the scenes as director of so many of the Gem's productions. His comic timing and pacing is sublime, the breaking of the fourth wall and periodic meta references are inspired (somebody get that man a cocktail!) and his song-and-dance is on par with any player whom audiences have seen strut across that stage.

It's a masterpiece of slapstick and satire, with phenomenal staging and performances by some of the best actors that the Gem has to offer. If there is a must-see in this 2018

season from One More Productions, "The Producers" is indubitably the one to watch.

**REQUEST:** A request to redevelop a 2.71-acre site, comprised of two parcels currently improved with the Starlight Cinema and a vacant 6,040 square foot restaurant, with a new automatic car wash, a new pad drive-thru restaurant, a new sit-down restaurant, and an expansion of the existing movie theater. The existing vacant restaurant building will be demolished to accommodate the proposed project. As part of the project, the Planning Commission will consider recommending that the City Council approve a text amendment to Planned Unit Development No. PUD-104-73 to include an automatic car wash, a drive-thru pad restaurant, and a sit-down restaurant as permitted uses on the subject project site, and to modify the sign requirements of the PUD to allow for multiple-tenant cabinets on the existing pole signs, to allow a vertical sign on a new tower building element of the movie theater, and to allow non-LED/non-digital movie poster board graphics to be displayed on the exterior marquee and wall display boards of the movie theater. The Planning Commission will also consider approval of a Lot Line Adjustment to modify existing lot lines to consolidate the two subject parcels into one; a Site Plan to allow the construction of a 4,241 square foot automatic car wash, an 1,870 square foot drive-thru restaurant, a 2,700 square foot sit-down restaurant, a 2,846 square foot movie theater expansion, and related site improvements; and a Conditional Use Permit to allow the operation of the automatic car wash. The site is in the PUD-104-73 (Planned Unit Development) zone.

**STAFF RECOMMENDATION:** Recommend approval of Planned Unit Development No. PUD-104-73 (REV. 2018) to City Council and approve Site Plan No. SP-057-2018, Conditional Use Permit No. CUP-140-2018, and Lot Line Adjustment No. LLA-019-2018, subject to the recommended Conditions of Approval. In conjunction, the Planning Commission will also consider a determination that the project is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15303 – New Construction or Conversion of Small Structures and Section 15301 – Existing Facilities – of the State CEQA Guidelines.

## **SB 946 (LARA) STREET VENDING – BILL ANALYSIS**

Orange County Division Members,

I've been receiving a lot of requests for an analysis on SB 946, the street vending bill that has been opposed by the League since its inception and was signed into law by Governor Brown. Down below and attached is a detailed bill analysis, however, here are the main points for cities to keep in mind:

1. Cities are prohibited from banning street vending.
2. Cities can regulate street vending within the parameters of SB 946, mainly with regard to health, safety, and welfare concerns.
3. Cities can require a street vendor to obtain a permit to operate, charge a business license fee, etc.
4. Street vending has been decriminalized – only punishable by administrative fines.
5. If a city fails to adopt a street vending ordinance in accordance with SB 946, the city has no ability to issue any citation or fine.

### **Bill Summary:**

This measure would prohibit a local authority from adopting rules or regulations, by ordinance or resolution, that regulate or prohibit sidewalk vendors unless it first adopts a sidewalk vending licensing program that requires a sidewalk vendor to obtain a license from the local authority before selling food or merchandise.

### **Bill Description:**

Specifically, SB 946 allows a local authority to adopt a sidewalk vending licensing program that requires a sidewalk vendor to obtain a license from the local authority before he or she is authorized to sell food or merchandise.

The local authority's licensing system shall comply with all of the following standards:

- A local authority shall not restrict the location of a licensed sidewalk vendor unless the restriction is directly related to objective health, safety, or welfare concerns.
- A local authority shall not prohibit a sidewalk vendor from selling food or merchandise in a park owned or operated by the local authority, except the local authority may prohibit stationary sidewalk vendors from vending in the park only if the operator of the park has signed an agreement for concessions that exclusively permits the sale of food or merchandise by the concessionaire.
- A local authority may adopt additional requirements regulating the time, place, and manner of sidewalk vending in a park owned or operated by the local authority if the requirements are any of the following:
  - Directly related to objective health, safety, or welfare concerns.

- Necessary to ensure the public's use and enjoyment of natural resources and recreational opportunities.
- Necessary to prevent an undue concentration of commercial activity that unreasonably interferes with the scenic and natural character of the park.
- A local authority shall not require a licensed sidewalk vendor to first obtain the consent or approval of any nongovernmental entity or individual before he or she can sell food or merchandise.
- A local authority shall not restrict sidewalk vendors to operate only in a designated neighborhood or area, except when that restriction is directly related to objective health, safety, or welfare concerns.
- A local authority may prohibit stationary sidewalk vendors in areas that are zoned exclusively residential, but shall not prohibit roaming sidewalk vendors.
- A local authority may prohibit sidewalk vendors in areas located within the immediate vicinity of a permitted certified farmers' market or a permitted swap meet during the limited operating hours of that certified farmers' market or swap meet.
- A local authority may restrict or prohibit sidewalk vendors within the immediate vicinity of an area designated for a temporary special permit issued by the local authority, provided that any notice, business interruption mitigation, or other rights provided to affected businesses or property owners under the local authority's temporary special permit are also provided to any sidewalk vendors specifically permitted to operate in the area, if applicable.
- A local authority shall not restrict the overall number of sidewalk vendor licenses issued unless the restriction is directly related to objective health, safety, or welfare concerns.
- Perceived community animus or economic competition does not constitute an objective health, safety, or welfare concern.
- A local authority may, by ordinance or resolution, adopt additional requirements regulating the time, place, and manner of sidewalk vending if the requirements are directly related to objective health, safety, or welfare concerns, including, but not limited to, any of the following:
  - Limitations on hours of operation that are not unduly restrictive. In nonresidential areas, any limitations on the hours of operation for sidewalk vending shall not be more restrictive than any limitations on hours of operation imposed on other businesses or uses on the same street.
  - Requirements to maintain sanitary conditions.
  - Requirements necessary to ensure compliance with the federal Americans with Disabilities Act of 1990 (Public Law 101-336) and other disability access standards.
  - Requiring the sidewalk vendor to obtain from the local authority a permit for sidewalk vending or a valid business license.
  - Requiring the sidewalk vendor to possess a valid California Department of Tax and Fee Administration seller's permit.
  - Requiring additional licenses from other state or local agencies to the extent required by law.
  - Requiring compliance with other generally applicable laws.
  - Requiring a sidewalk vendor to submit information on his or her operations, including, but not limited to, any of the following:
    - The name and current mailing address of the sidewalk vendor.
    - A description of the merchandise offered for sale or exchange.

- certification by the vendor that to his or her knowledge and belief, the information contained on the form is true.
- The California seller's permit number (California Department of Tax and Fee Administration sales tax number), if any, of the sidewalk vendor.
- If the sidewalk vendor is an agent of an individual, company, partnership, or corporation, the name and business address of the principal.

A violation of a local authority's sidewalk vending program that complies with Section 51038 is punishable only by the following:

- An administrative fine not exceeding one hundred dollars (\$100) for a first violation.
- An administrative fine not exceeding two hundred dollars (\$200) for a second violation within one year of the first violation.
- An administrative fine not exceeding five hundred dollars (\$500) for each additional violation within one year of the first violation.
- A local authority may rescind a permit issued to a sidewalk vendor for the term of that permit upon the fourth violation or subsequent violations.

If a local authority requires a sidewalk vendor to obtain a sidewalk vending permit from the local authority, vending without a sidewalk vending permit may be punishable by the following:

- An administrative fine not exceeding two hundred fifty dollars (\$250) for a first violation.
- An administrative fine not exceeding five hundred dollars (\$500) for a second violation within one year of the first violation.
- An administrative fine not exceeding one thousand dollars (\$1,000) for each additional violation within one year of the first violation.
- Upon proof of a valid permit issued by the local authority, the administrative fines shall be reduced to the administrative fines set forth in paragraph (1).

Failure to pay an administrative fine shall not be punishable as an infraction or misdemeanor. Additional fines, fees, assessments, or any other financial conditions beyond those authorized in this measure shall not be assessed.

A violation of a local authority's sidewalk vending program that complies with Section 51038, or a violation of any rules or regulations adopted prior to January 1, 2019, that regulate or prohibit sidewalk vendors in the jurisdiction of a local authority, shall not be punishable as an infraction or misdemeanor, and the person alleged to have violated any of those provisions shall not be subject to arrest except when permitted under law.

This shall apply to all pending criminal prosecutions under any local ordinance or resolution regulating or prohibiting sidewalk vendors. Any of those criminal prosecutions that have not reached final judgment shall be dismissed.

A local authority that has not adopted rules or regulations by ordinance or resolution that comply with Section 51037 shall not cite, fine, or prosecute a sidewalk vendor for a violation of any rule or regulation that is inconsistent with the standards described in subdivision (b) Section 51038.

“Sidewalk vendor” is a person who sells food or merchandise from a pushcart, stand, display, pedal-driven cart, wagon, showcase, rack, or other non-motorized conveyance upon a public sidewalk or other pedestrian path.

“Roaming sidewalk vendor” means a sidewalk vendor who moves from place to place and stops only to complete a transaction.

“Stationary sidewalk vendor” means a sidewalk vendor who vends from a fixed location.

“Local authority” means a chartered or general law city, county, or city and county.

# Corona Police Sergeant Unseats CalPERS Public Agency Board Representative Incumbent

*October 5, 2018*

Corona Police Sergeant Jason Perez has defeated four-time incumbent and current CalPERS Board of Administration President Priya Mathur.

The election for the active public agency representative position was held Sept. 1–30. While the results are still preliminary pending formal certification by the California Secretary of State, Perez received 56.78 percent of the vote and Mathur received 43.22 percent.

Voter turnout for this seat has historically been low. During the previous election cycle, there was only a 6.8 percent voter turnout. This election saw an uptick in voter turnout at 8.4 percent. Unlike the two at-large seats currently held by Margaret Brown and David Miller, the active public agency member seat represents CalPERS members employed by cities, counties and special districts.

Perez and other officers from the Corona Police Officers Association have been regular attendees at CalPERS board meetings. Perez has often joined his assistant city manager and vice mayor in urging CalPERS to abandon their pursuit of environmental and social investment programs and instead focus solely on maximizing investment returns to ensure that local agencies can retain employees and keep the commitments made to their employees.

Most notably Perez challenged former gubernatorial candidate and outgoing State Treasurer John Chiang, a CalPERS board member, when he urged his colleagues to approve a divestment policy that would force the fund to sell off all shares of nationwide retailers that sell semi-automatic weapons. According to Perez, it was this action that prompted him to run for the position.

Perez will begin serving his four-year term Nov. 1. Additionally, two other incumbents ran unopposed for two board seats up for re-election: Theresa Taylor, the state member representative; and Rob Feckner, the school member representative. The Secretary of State officially certified their election on June 8, 2018.
