The City of Garden Grove writes to express an Oppose Unless Amended position on your SB 9, which would require a local government to ministerially approve a housing development containing two residential units in single-family residential zones. Additionally, this measure would require local governments to ministerially approve urban lot splits.

Housing affordability and homelessness are among the most critical issues facing California cities. Affordably priced homes are out of reach for many people and housing is not being built fast enough to meet the current or projected needs of people living in the state. Cities lay the groundwork for housing production by planning and zoning new projects in their communities based on extensive public input and engagement, state housing laws, and the needs of the building industry.

While your desire to pursue a housing production proposal is appreciated, unfortunately, SB 9 as currently drafted would not spur much needed housing construction in a manner that supports local flexibility, decision-making, and community input. State driven ministerial or by-right housing approval processes fail to recognize the extensive public engagement associated with developing and adopting zoning ordinances and housing elements that are certified by the California Department of Housing and Community Development (HCD).

The City of Garden Grove requests the following amendments in order to address our concerns and remove our opposition:

- Clarify that a property owner using SB 9 is limited to constructing two residential units, not two residential units and additional accessory dwelling units (ADUs) on the same parcel;
- Require a housing developer to acquire a building permit within one year of a lot split, so that speculators do not sell lots and never build homes;
- Allow local governments to require adequate access for police, fire and other public safety vehicles and equipment;
- Prohibit developers from using SB 9 in very high fire hazard severity zones;
- Allow cities to determine a range of lot sizes suitable for SB 9 development projects;
- Ensure HCD provides Regional Housing Needs Allocation (RHNA) credit for production of SB 9 units;

- Allow local governments to take into account local conditions such as hillsides, lot dimensions, natural hazards, available infrastructure, etc. when approving or denying housing project applications;
- Allow local governments to continue to determine parking standards; and
- Ensure large-scale investors and builders do not exploit SB 9 provisions.

The City of Garden Grove is committed to being part of the solution to the housing shortfall across all income levels and will continue to work collaboratively with you to spur much needed housing construction. Thank you for considering the above amendments.

For these reasons, the City of Garden Grove opposes SB 9 (Atkins) unless it is amended to address our concerns.


• Anaheim continues to resist updating 1986 Shared Sewer Agreement. The main stumbling block is that they do not want to lower the current d/D ratio of 0.75.



We write today as the duly elected officials of the fifth-most populous County in the United States representing more than 3.3 million people to advocate for the passage of additional funding for state and local governments as well as vaccine funding in the next COVID-19 relief bill.

We have been working at the county and municipal levels as partners to rebuild the economy and streamline vaccine rollouts. Despite experiencing historic budget shortfalls, we continue to manage mounting costs and increasing demands to protect our residents. Previous federal legislation responding to COVID-19 provided important support, yet none allowed for the replacement of billions of lost revenues due to COVID-19.

Amid caring for coronavirus patients, the County has begun vaccinating residents age 65 and older. However, our County is quickly going through our vaccine supply. To successfully reach our goal of at least 30,000 vaccinations a day and accommodate for our new vaccine "super sites," our County desperately needs increased quantities of the vaccine. We will not overcome this virus without a vigorous vaccine program, which requires increased funding.

As Congress prepares its priorities for the early months of 2021, leaders in Congress and the Executive Branch have made it clear COVID-19 recovery is the foremost priority. The most impactful measure Congress can take to stabilize our COVID-19 situation and encourage economic revival is to provide aid to local governments. We are urging Congress to:

- Provide direct aid to local governments equally divided between cities and counties. Please do not place states in a position of intermediary in this aid.
- Provide maximum flexibility. Financial struggles of local governments in their COVID-19
 responses vary in scope. Congress should ensure the direct aid can cover the widest set
 of eligible activities, including forgone revenue.

- Provide a robust amount of aid. Congress should appropriate additional funds on the order of magnitude larger than the \$150 billion provided in the Coronavirus Relief Fund in March.
- Establish no minimum population. In prior COVID relief legislation, Congress provided direct aid to communities with a minimum population of 500,000 and 200,000. We urge Congress to make the funding available without a statutory minimum population.

As proposed, President Biden's COVID relief package addresses a number of our concerns as it relates to state and local government aid: (1) it provides \$350 billion in emergency aid to state and local governments; (2) it allocates \$20 billion towards a national vaccination program; and (3) it provides \$130 billion to help our K-12 schools reopen. This package would keep public workers employed, increase vaccine distribution, expand virus testing, and reopen schools. President Biden recognizes the urgency of this moment and the need to support counties across the U.S.

We are also encouraged by the President's recognition of the need for the federal government to reimburse local governments for coronavirus-related expenses, as indicated by his recent executive action to increase the Federal Emergency Management Agency Public Assistance cost share to 100 percent. If the federal government expands staffing for vaccines, the County and all its contained cities stand ready to offer our support of increased staff – as long as the federal government will reimburse the cost.

Local governments have been on the front lines of this crisis. We implore you to prioritize the passage of additional funding for state and local governments and vaccine programs. We look forward to continuing to work with you to address our concerns while advancing the passage of the next COVID-relief package.

COVID-19 Vaccine Super POD Site Opens at Anaheim Convention Center to Administer Second Doses of the Moderna Vaccine

Santa Ana, Calif. (February 17, 2021) — The Orange County Health Care Agency plans to open a new Super POD site at the Anaheim Convention Center, increasing vaccine dispensing capacity as more people are due to receive a second dose of the COVID-19 vaccine.

Effective February 24, 2021, everyone who received the first dose of the **Moderna COVID-19 vaccine** at the Disneyland Super POD site will receive the second dose at the Anaheim Convention Center Super POD site. After February 24, Disneyland will only dispense Pfizer, both first and second doses. The Anaheim Convention Center site will only dispense Moderna, first and second doses.

The second dose appointment will remain at the same date and time; only the location will change. Othena will send a notification to everyone whose appointment location is affected by this change.

The Health Care Agency operates Super POD sites at the Disneyland Resort, Soka University, and soon the Anaheim Convention Center. Appointments for the County's Super POD sites are scheduled through the Othena.com user platform.

Vaccination appointments are currently available to individuals classified under the "Phase 1a, all tiers" eligible vaccine distribution group as established by the California Department of Public Health (CDPH), as well as those who work as first responders in high-risk communities or who are 65 years of age or over. Proof of eligibility is required.

Vaccinations are by appointment only. Those scheduled for an appointment are encouraged to arrive no more than 30 minutes before their appointment time and dress appropriately for the weather. Individuals without an appointment will be turned away.

The County Super PODs and mobile clinics are not the only options to receive a vaccination. Other healthcare providers approved to dispense the vaccine, including hospitals, pharmacies and health clinics, play an essential role in vaccinating Orange County's population.

The UWMP presents Metropolitan's long-term plan for ensuring water supply reliability and water quality for the region. The draft 2020 UWMP complies with California state law requiring urban water suppliers to prepare and update urban water management plans every five years. 
Monthly Water Usage Data, Tier 2 Projection & Water Supply Information

The attached figures show the recent trend of water consumption in Orange County (OC), an estimate of Imported Water Sales for MWDOC, and selected water supply information.

- OC Water Usage, Monthly by Supply OCWD Groundwater was the main supply in December.
- Estimated OC Water Usage, Monthly, Comparison to Previous Years
 in December 2020 was above average compared to the last 5 years. We are
 projecting a slight decrease in overall water usage compared to FY 2019-20. It has
 been 45 months since all mandatory water restrictions were lifted by the California
 State Water Resources Control Board.
- Historical OC Water Consumption Orange County M & I water consumption is projected to be 525,000 AF in FY 2020-21 (this includes ~15 TAF of agricultural usage and non-retail water agency usage). This is about 9,000 AF less than FY b2019-20 and is about 10,000 AF more than FY 2018-19. Water usage per person is projected to be slightly lower in FY 2020-21 for Orange County at 146 gallons per day (This includes recycled water). Although OC population has increased 20% over the past two decades, water usage has not increased, on average. A long-term decrease in per-capita water usage is attributed mostly to Water Use Efficiency (water conservation) efforts. O.C. Water Usage for the last five Fiscal Years is the lowest since the 1982-83 Fiscal Year (FY 1982-83 was the third wettest year on record).

<u>Water Supply Information</u> Includes data on Rainfall in OC; the OCWD Basin overdraft; Northern California and Colorado River Basin hydrologic data; the State Water Project (SWP) Allocation, and regional storage volumes. The data has implications for the magnitude of supplies from the three watersheds that are the principal sources of water for OC. Note that a hydrologic year is Oct. 1st through Sept. 30th.

- Orange County's accumulated precipitation through early February was below average for this period. Water year to date rainfall in Orange County is 3.58 inches, which is 52% of normal.
- Northern California accumulated precipitation through early February was 55% of normal for this period. Water Year 2020 was 63% of normal while water year 2019 was 137% of normal. The Northern California snowpack was 73% as of February 4th. As of early February, 85.99% of California is experiencing moderate to exceptional drought conditions while 100.00% of the state is experiencing abnormally dry conditions. The State Water Project Contractors Table A Allocation was set at 10% in December 2020.
- Colorado River Basin accumulated precipitation through early February was 66% of normal for this period. The Upper Colorado Basin snowpack was 75% of normal as of February 3rd. Lake Mead and Lake Powell combined have about 58% of their average storage volume for this time of year and are at 40.1% of their total capacity. If Lake Mead's level falls below a "trigger" limit 1,075 ft. at the end of a calendar year, then a shortage will be declared by the US Bureau of Reclamation (USBR), impacting Colorado River water deliveries to the Lower Basin states. As of early October, Lake Mead levels were 11.38' above the "trigger" limit. The USBR predicts that the start of 2020 will not hit the "trigger" level but there is a 60% chance that the trigger level will be hit in 2022 and a 82% chance in 2023.






Accumulated Precipitation

for the Oct.-Sep. water year, early February 2021







OC won't start vaccinating teachers, food workers for at least two weeks

By ALICIA ROBINSON | arobinson@scng.com | The Orange County Register PUBLISHED: February 9, 2021 at 5:51 p.m. | UPDATED: February 10, 2021 at 8:32 a.m. Orange County will wait at least another two weeks before offering COVID-19 vaccine shots to educators, food service workers and others who are newly eligible under state guidelines, county Health Officer Dr. Clayton Chau said Tuesday. Feb. 9.

The additional time will help the county get through a waiting list of people 65 and older who haven't been vaccinated yet, Chau told the Orange County Board of Supervisors.

So far, about 100,000 of Orange County's seniors, plus most of the county's health care workers who wanted shots, have been inoculated, Chau said – but those two groups together equal more than 700,000 people, and vaccine supplies continue to be limited.

Chau said with the county getting only about 37,000 doses a week from the state, inviting more people to compete for them would just lead to more frustration.

"We've only at best vaccinated a quarter of them (seniors) – I cannot open up the door for more of them to come in when we still have the same number of vaccines," he said.

After kicking off vaccinations of health care workers in mid-December, Orange County was one of the first to offer shots to anyone 65 and older starting about a month ago.

Chau followed the recommendation of the county's vaccine task force and opened appointments to seniors after seeing statistics from about a dozen hospitals that showed about three quarters of the people hospitalized with serious complications or dying from COVID-19 were in the older age group.

The county's vaccine task force, as well as a supervisors' ad hoc committee, agreed with the decision to stay focused for the next two weeks on those 65 and older, especially those most vulnerable and in parts of the county that have active hot spots of the virus, Chau said.

Statewide, Orange County is second behind Los Angeles County with the largest percentage of residents in the 65-and-older bracket, he said. Neighboring Long Beach has been able to vaccinate its health care workers and smaller population of seniors and has now opened up appointments to teachers, Chau said.

Orange County's health agency gets about 20% of the doses designated for the county (most go to major medical providers that serve multiple counties and pharmacy chains), so Chau has to rely on third parties and the state for information on how the rest of the vaccines get used.

Supervisor Lisa Bartlett said the state's vaccine database is plagued with incomplete or inaccurate information, including missing ZIP codes of many residents who were inoculated, which is making it harder for county health officials to figure out where to target outreach and set up clinics.

"The state database is so erroneous it's affecting our second dose levels," she said, adding that Los Angeles County this week had to halt new appointments to catch up on follow-up shots.

"Until we can get accurate ZIP code information we're not really going to know what's happening in underserved areas," she added.

Chau told supervisors that in addition to the super sites at Disneyland and Soka University and a weekend mobile POD (point of dispensing), the county health agency is working with community clinics and nonprofits to bring vaccinations to people in neighborhoods with high infection rates or who may have trouble getting to the two big sites.

Officials are planning vaccination sites in Santa Ana and Anaheim, which include neighborhoods with some of the county's highest infection rates, and additional pods may be coming to Santa Ana College and Christ Cathedral in Garden Grove, Chau said.

The Othena platform the county has for people to register for vaccines and make appointments last week added support in Spanish and on Tuesday added Vietnamese and is "moving swiftly" to add Korean and Chinese, Chau said.

The county's hotline, 714-834-2000, can help seniors who aren't tech savvy with the process.

"We have had staff able to speak Vietnamese and Spanish on the hotline," Chau said, adding county officials recognize that might not meet demand and are in process of contracting with a call center and training its staff to add to the number of people the hotline can serve and in what languages.

Chau has asked for residents' patience as the county works through the challenges of vaccinating about 3.1 million people with a limited supply, and he repeated that request Tuesday, though he said he hopes for many the wait will end sooner rather than later.

A panel of the federal Food and Drug Administration is set to meet Feb. 26 to consider allowing use of Johnson & Johnson's new vaccine, which only requires one shot and would help ease the supply problem.

"If the FDA authorizes it, presumably the following Monday or Tuesday (March 1 or 2) we should have our first shipment of Johnson & Johnson in Orange County," Chau said.

"I look forward to a month from now when we have plenty of vaccine ... to offer to any of our citizens who want the vaccine."

Customer sent to prison for killing Garden Grove nail salon manager in Las Vegas parking lot incident

LAS VEGAS — A Las Vegas woman was sentenced Friday to 10 to 25 years in prison for killing a nail salon manager with a vehicle while trying to skip out on a \$35 manicure. Krystal Whipple in December pleaded guilty to second-degree murder, admitting she killed Nhu "Annie" Ngoc Nguyen, a 51-year-old mother of three from Garden Grove, in December 2018.

Clark County District Court Judge Tierra Jones sentenced Whipple, whose plea allowed her to avoid trial on felony murder, burglary, robbery and stolen vehicle charges.


Police said Whipple, 23, tried to pay for her manicure with a fraudulent credit card before telling Nguyen that she was going to her car to get cash.

Nguyen and her boyfriend followed Whipple into the parking lot, where Nguyen was struck and dragged by a black Chevrolet Camaro driven by Whipple. Police later said the car had been stolen from a rental agency.

Authorities said Whipple fled to Boulder City and then Los Angeles before surrendering to police in the Phoenix suburb of Glendale, Arizona, almost two weeks after Nguyen's death.

Mass vaccination site at Anaheim Convention Center will be OC's 3rd

Orange County plans to launch its third mass vaccination Super POD (point of dispensing) at the Anaheim Convention Center next week, opening a new front in the county's campaign to protect millions of residents from the coronavirus.

Starting Wednesday, Feb. 24, the convention center will serve as both a COVID-19 testing and immunization site.

The convention center will join other nodes in a growing regional web of large, small, public and private vaccination centers on the frontlines of a vast public health campaign to immunize as many people as possible from COVID-19, starting with the most vulnerable.

It also will be the second public mass vaccination center in Anaheim, Orange County's most populous city. The outdoor <u>Disneyland Super POD opened Jan. 13</u> in one of the theme park's parking lots, a half mile from the convention center on Katella Avenue.

Once up and running, the convention center site is expected to vaccinate as many people per day as the Disneyland site – about 5,000 – and because it's indoors, it will be sheltered from the kind of inclement weather that forced the tented Disneyland site to close three times in the month since it launched.

Another large-scale, indoor site <u>opened Jan. 23 at Soka University in Aliso Viejo</u>, a closer option for south county residents, and several smaller day-long clinics have popped up, inviting certain vulnerable groups of senior residents.

Orange County supervisors and OC Health Care Agency officials have said they ultimately envision five county-run mass vaccination sites around the county, but they are only bringing them online as supplies of doses from the state grow. Other health care entities, such as traditional providers and pharmacy chains, have launched their own programs.

Appointments for the convention center site also will be made via the county's <u>Othena</u> appointment system. None of the county's vaccination centers are open to walk-ups. Qualified patients who are having trouble with Othena are asked to call a county hotline at 714-834-2000.

After first opening up vaccinations to <u>health care workers and some law enforcement</u>, the county expanded eligibility to those 65 and older — the primary focus now of most efforts.

Of 656,000 people registered since Othena's launch in January (people who aren't yet eligible can register for notification when they are), 198,000 doses have been administered, Othena's website showed Wednesday, Feb. 17.

Starting Feb. 24, "everyone who received the first dose of the Moderna COVID-19 vaccine at the Disneyland Super POD site will receive the second dose at the Anaheim Convention Center Super POD site," county officials said in a press release Wednesday evening.

After that date, Disneyland will only dispense Pfizer-BioNTech vaccines, which require a three-week gap between first and second doses, and the convention center will only dispense Moderna vaccines, which require a four-week gap.

"The second dose appointment will remain at the same date and time; only the location will change. Other will send a notification to everyone whose appointment location is affected by this change," the press release said.

Being home to two super-sites will make Anaheim a pandemic-fighting hub, said Mayor Harry Sidhu.

"These two sites will provide more options for Anaheim residents to get vaccinated where they live, while also serving people from across Orange County," he said.

The city is home to many who have been disproportionately impacted by the pandemic – people with lower incomes and less access to health care who can't isolate from others if they're exposed to COVID-19 and don't have jobs that allow them to work from home.

On Wednesday, county officials <u>launched a smaller-scale vaccination site at Santa Ana College</u> to target eligible people who live in hard-hit communities in Santa Ana, Anaheim and Garden Grove. The center will be open to only those in targeted ZIP codes and is expected to inoculate about 1,000 people each day and will be closed Sundays and Mondays.

OC opens COVID-19 vaccination site at Santa Ana College to target hard-hit areas

A new vaccination site at Santa Ana College opening Wednesday, Feb. 17, aims to serve eligible residents in Anaheim, Garden Grove and Santa Ana neighborhoods that have seen some of the highest COVID-19 infection rates in the county and the largest numbers of people hospitalized or killed by the virus.

Like the county's other PODS (points of dispensing), vaccinations at the Santa Ana College site will be by appointment only. Unlike the super sites at Disneyland and Soka University, the 1,000 slots a day at Santa Ana College will only be available to people in select ZIP codes that have been hardest hit by COVID-19.

The new site will run from 8 a.m. to 5 p.m. Tuesdays through Saturdays. Registration and scheduling are done through the Othena app and website (www.othena.com). The site will include vaccination stations indoors and a drive-thru option for people with mobility issues.

"It's a really good strategic move to put this (vaccination) center in this city and this community that has been hit so hard," Rancho Santiago Community College District Chancellor Marvin Martinez said. "The community here is very familiar with the college, they feel safe, they feel that it's a credible, legitimate institution and they feel really comfortable coming to the campus."

Anaheim and Santa Ana have seen the most infections by far since the beginning of the pandemic, with 40,450 total cases in Anaheim and 43,579 in Santa Ana; just four other cities in the county (Fullerton, Garden Grove, Huntington Beach and Orange) have broken the 10,000-case mark to date, according to county data.

Over the summer, county officials recognized certain areas were COVID-19 case "hot spots," where residents may live in more crowded households, are more likely to work public-facing essential jobs, or face barriers such as language or transportation. They began targeting those neighborhoods with information and pop-up coronavirus testing sites, and the new vaccination center is a continuation of those efforts.

"Addressing barriers that may impede people's access to testing and vaccines, especially in low equity communities, is the reason why we came up with the Latino Health Equity Initiative very early in the pandemic," Orange County Supervisor Andrew Do said in a statement. "The Santa Ana College site is a tangible example of the county and Board of Supervisors delivering on our focus on equity in vaccine distribution."

County CEO Frank Kim said the goal of the new site is "to ensure that we're not leaving any group behind."

The county is alerting people 65 and older who live in the affected ZIP codes and are registered with Othena that they can make an appointment for the Santa Ana College site, and it's doing other outreach to eligible seniors who haven't yet signed up through Othena, Kim said.

Martinez said the district will be reaching out to Spanish, Vietnamese and Cambodian media to help get the word out to residents about the vaccinations.

Santa Ana Mayor Vicente Sarmiento said it's "extremely important to me" that vaccination efforts focus on neighborhoods with high COVID-19 case counts.

"I'm obviously excited that there is going to be a vaccination site here in in Santa Ana, and I'm even more glad that it is going to be addressing some of the most impacted residents in our community and our county," he said.



The draft meets Cal Cities' strategic advocacy goal of delivering direct and flexible federal resources for pandemic response and recovery for cities of all sizes. In addition, there is no minimum population requirement, and the funding can be used to replace lost revenue, which is a first!

Thank you and all of our members who joined Cal Cities in urging congressional leadership to take swift and urgent action on comprehensive coronavirus relief legislation that includes direct and flexible funding for all cities.

This is also the message Cal Cities President Cheryl Viegas Walker and I delivered to former Cal Cities president and now Senator Alex Padilla, and representatives from Senator Dianne Feinstein and Congressman Juan Vargas' offices when we met with them last week.

The pandemic is not over, and our cities have been waiting for months to receive meaningful aid from the state and federal governments. This proposal is a first step towards securing the federal funds needed to continue our efforts on the front line fighting this pandemic and helping our communities recover from it.

Cal Cities will continue the push to ensure the passage of this proposal in the Committee markup later this week and beyond. We recognize that more is needed and will also continue to push for state resources to help cities respond and recover from this pandemic.

Next Steps

The bill text and markup memo for House Oversight and Reform Committee for state and local emergency relief can be found here. The Committee will vote on the draft this Friday starting at 12 p.m. Following passage, it will be delivered to the House Budget Committee to be assembled into the broader emergency aid package.

Other sections of the aid package that are likely to get committee votes this Friday include the transportation assistance section and the housing assistance section, both of which have Cal Cities' support.

Several California House members sit on the House Oversight and Reform Committee (chart below). Cal Cities will be reaching out to them to indicate our support for the bill they will be marking up on Friday. We will also be coordinating with California city officials with members on these committees and urging them to reach out as well.

Key Provisions of the House Committee Proposal

Main points for municipalities:

- \$350 billion in total for all municipalities, counties, states, tribes, and territories. Of that amount:
 - \$130 billion is set-aside for local governments, equally divided between municipalities and counties.
 - The \$65 billion for municipalities will be allocated to all 19,000 municipalities according to a modified Community Development Block Grant formula. Under that formula:
 - \$45.5 billion will be split among all municipalities that are designated CDBG entitlement cities (generally cities with populations above 50,000 residents)
 - \$19.5 billion will be split among cities not designated CDBG entitlement cities (generally cities with populations below 50,000 residents)

Of the remaining funds:

- \$195 billion for states and the District of Columbia
- \$65 billion for counties
- \$20 billion for tribes
- \$4.5 billion for territories

Additional details:

- No deadline for spending down funds
- Eligible expenditures will include replacement of lost revenue

- The U.S. Treasury Department will allocate funds in similar fashion to CDBG.
 - Funding for CDBG entitlement cities (generally above 50,000 residents) will be determined by the CDBG formula.
 - Funding for non-entitlement cities (generally below 50,000 residents) will be allocated based on population.

Cal Cities-sponsored bond agency issues \$181 million in taxexempt bonds for Anaheim project through new workforce housing funding program

February 10, 2021

Affordable housing properties have been acquired for middle-income residents in the city of Anaheim from the issuance of more than \$181 million in tax-exempt Essential Housing Revenue Bonds through the California Statewide Communities Development Authority (CSCDA).

The Anaheim project was the third closing under the new CSCDA Workforce Housing Program.

Parallel Apartments

Constructed in 2018, the Parallel Apartments in Anaheim provides a 386-unit, multi-family residential rental community. The project will guarantee that studio and one- and two-bedroom units will be restricted for households earning less than 80, 100, and 120 percent of the area median income (AMI).

CSCDA partnered with the city of Anaheim and others, in connection with the acquisition of the project and issuance of \$181.01 million in tax-exempt bonds.

About CSCDA's new Workforce Housing Program

Since its beginning, CSCDA has financed the construction or preservation of nearly 100,000 affordable units throughout California. Despite these efforts, affordable housing for all income levels still remains in short supply.

Workforce housing is intended for those that have been termed the "missing middle", individuals and families that earn too much to qualify for traditional affordable housing, but not enough to afford market-rate rents in the communities where they work. Workforce housing is for middle-income or moderate-income individuals and families typically earning between 80 percent and 120 percent AMI. Unfortunately, workforce housing is not eligible for tax credits, private activity bonds, or most other federal, state, or local government subsidies.

Through CSCDA's Workforce Housing Program, government bonds are issued to acquire marketrate apartment buildings. These properties are then converted to income and rent-restricted units for moderate and middle income households. Annual rent increases are capped at no more than 4 percent, which is less than the rent limits under AB 1482, the recently adopted state tenant-protection legislation. Additionally, no existing tenants are displaced under the program.

The League of California Cities' co-sponsorship of CSCDA continues to be a significant benefit for League members. CSCDA has issued more than \$63 billion in tax-exempt bonds for projects that provide a public benefit by creating jobs, affordable housing, healthcare, infrastructure, schools, and other fundamental services.

CSCDA is a joint powers authority created in 1988 and is sponsored by Cal Cities and the California State Association of Counties. More than 530 cities, counties, and special districts are program participants in CSCDA, which serves as their conduit issuer and provides access to efficiently financed, locally-approved projects.

Coalition seeks urgent changes to Beverage Container Recycling Program to increase convenience of consumer redemption opportunities

February 10, 2021

The League of California Cities, the Rural County Representatives of California (RCRC), the Rural Counties' Environmental Services Joint Powers Authority (ESJPA), and the California State Association of Counties (CSAC) submitted <u>a letter</u> to the Legislature this week urging prompt action to make several urgent changes to the Beverage Container Recycling Program to address the lack of convenient redemption opportunities in many parts of the state.

With the closure of many certified recycling centers, "convenient" beverage container redemption opportunities do not exist for many Californians in rural and even urban areas. Statewide <u>data</u> from the California Department of Resources Recycling and Recovery (CalRecycle) illustrates the lack of recycling centers, with five or fewer recycling centers in 31 of California's 58 counties.

Without convenient redemption opportunities, the Beverage Container Recycling Program can easily become a regressive tax that disproportionately impacts lower-income Californians. These concerns are even more acute during the COVID-19 pandemic when many Californians are already struggling to make ends meet.

The letter recognizes CalRecycle's recently suggested eight <u>emergency legislative actions</u> to increase the convenience of redemption opportunities and recognizes that many of those ideas will meaningfully improve the state's beverage container recycling efforts and redemption opportunities. In addition to CalRecycle's suggestions, the letter details nine recommended actions to benefit local governments.

The suggested actions will help to quickly increase the number and convenience of redemption opportunities in rural and underserved areas of the state. Renewed commitment to transportation infrastructure urged by 'Fix Our Roads' Coalition

February 10, 2021

The League of California Cities joined fellow members of the Fix Our Roads Coalition and submitted <u>a letter</u> last week to the newly-appointed chairs of the state Senate and Assembly Transportation Committees.

The letter details the coalition's efforts to pass and protect <u>SB 1</u> funding and commits to working together to address the future of transportation in California.

SB 1 is the largest investment in multimodal transportation infrastructure in the state's history and provides \$5 billion annually to local governments to fix crumbling roads, make road and bridge safety repairs, alleviate traffic gridlock and congestion, improve bicycle and pedestrian access and safety, and boost funding to both expand and operate public transit services for Californians.

Protecting SB 1 funding is a top priority for Cal Cities, and we look forward to working with the new committee chairs on this important issue.

The start of a new legislative session meant new leadership for the Senate and Assembly Transportation Committees. Assembly Speaker Anthony Rendon replaced Assembly Member Jim Frazier with Assembly Member Laura Friedman. Senate President pro Tem Toni Atkins appointed Sen. Lena Gonzalez to chair with Sen. Jim Beall's departure from the Legislature. These appointments signal a change in legislative priorities for these committees, as both Assembly Member Frazier and Sen. Beall were instrumental in the passage of SB 1.

The Fix Our Roads Coalition was created in 2015 by Cal Cities, the California State Association of Counties, and the California Alliance for Jobs to pursue funding for California's deteriorating transportation infrastructure. The coalition of labor, local government, business, transportation, and public transit advocates will continue to advance a transportation agenda that helps ensure a safe, reliable, and accessible transportation system for all Californians.

Funding rollout of eviction protections and State Rental Assistance Program

February 10, 2021

Just days before the existing eviction moratorium was set to expire, the state extended the COVID-19 Tenant Relief Act – <u>SB 91</u> on Jan. 29, 2021. The measure was passed with urgency and went into effect immediately upon signature.

In response to the ongoing eviction and shelter crisis facing communities throughout California, SB 91 extends the statewide moratorium on evictions for nonpayment of rent due to COVID-19 financial hardship to June 30, 2021, and establishes the State's Emergency Rental Assistance Program. The U.S. Treasury Department allocated \$2.6 billion to California for the program, with \$1.5 billion of federal rental relief funds to go toward implementation of a statewide rental assistance program, and \$1.1 billion to go to California's largest cities and counties according to federal law.

Emergency Rental Assistance Program


The Evictions Moratorium and State Rental Assistance Program funds can be used for back rent, prospective rent payments, and utility payments. Specifically, \$150 million is earmarked for counties under 200,000 population (and cities within) and \$1.32 billion is earmarked for cities and counties over 200,000 population.

The program will begin accepting applications no later than March 15 and will prioritize the payment of rental arrearages. Utility arrearages will also be eligible to be paid, subject to funding availability. Landlords can choose to accept 80 percent of any unpaid rent owed from April 1, 2020 through March 31, 2021. If a landlord accepts this funding, the landlord agrees to forgive the remaining unpaid rent for that covered period. If a landlord chooses not to participate, the tenant can still apply for relief valued at 25 percent of unpaid back rent they owe for the covered period. Qualified tenants will also be able to access funds to cover 25 percent of prospective rent for the months of April, May, and June of 2021, subject to funding availability.

Funding will be administered in three rounds:

- Round 1 Households with less than 50 percent Area Median Income (AMI)
- Round 2 Communities disproportionately impacted by COVID-19, as determined by the California Department of Housing and Community Development

• Round 3 - Households with less than 80 percent AMI



Additional information on the State's Rental Assistance Program is forthcoming. <u>A presentation</u> from the California Business, Consumer Services and Housing Agency on SB 91 and the State's Rental Assistance Program is available for those interested.

Eviction Moratorium extended

The Act also extends tenant protections included in the Tenant, Homeowner, and Small Landlord Relief and Stabilization Act of 2020 (AB 3088) to June 30, 2021. These protections were originally set to expire on Feb. 1, 2021. The Act includes the same eligibility and program rules as before including:

- Prevents evictions for nonpayment of rent by tenants experiencing a COVID-19 hardship.
- Available to any tenant who timely attests under penalty of perjury that they have not been able to pay full rent due to COVID-19-related circumstances.
- If a tenant pays at least 25 percent of their rent owed between September 2020 and June 2021, they are permanently protected from eviction for not paying their full rent during this period; however they will still owe their landlord all unpaid rent.
- Landlords may still proceed with certain other types of "just cause" evictions unrelated to a tenant's failure to pay rent.

Protection for tenants and property owners impacted by COVID-19

Additionally, SB 91 provided the following relief to tenants and property owners impacted by COVID-19.

- Limiting public disclosure of eviction cases involving nonpayment of rent between March 4, 2020 and June 30, 2021.
- Protects low-income tenants from landlords assigning or selling their rental debt to a thirdparty debt collector.
- "Pay or Quit" notice period for nonpayment of rent extended from three to 15 days.
- Protects tenants from being evicted for "just cause" if landlord is shown to be really evicting the tenant for COVID-19 related nonpayment of rent.
- Landlord may not charge late fees for nonpayment of rent between March 1, 2020 and June 30, 2021 to tenants who have attested they are experiencing a COVID-19-related hardship.
- Require landlords to notify all tenants who owe back rent about the availability of their rights and the rental assistance program via an informational notice by Feb. 28, 2021.
- Provides extended consumer protections for requests of mortgage forbearance for homeowners impacted by COVID-19 until Sept. 1, 2021.

Cal Cities launches Public Safety Task Force to inform advocacy efforts around police reform

February 17, 2021

In response to the growing sense of urgency for cities around issues involving public safety and policing reform, the League of California Cities board directed staff at its December meeting to establish a group of local officials to develop recommendations that will help inform and guide Cal Cities' advocacy efforts at the state level.

During last week's board meeting, Cal Cities President and El Centro Mayor Cheryl Viegas Walker announced the creation of a Public Safety Task Force, and introduced the diverse set of local officials who make up this important group.

The Legislature has taken steps to improve public safety and reform policing in recent years, but there's more work to be done, and growing interest by cities in modernizing their approach to delivering public safety services in their communities. The Public Safety Task Force will review and recommend updates to Cal Cities' public safety policy and guiding principles, which will be delivered to the Public Safety Policy Committee for consideration in April.

The task force will host its first meeting tomorrow, Feb. 18, where they will discuss 21st Century Policing and other initiatives.

Cal Cities opposes unless amended legislation seeking to increase density in single-family zoned neighborhoods without respect to locally adopted housing plans

Cities are encouraged to submit letters to legislators as soon as possible February 17, 2021

The League of California Cities Board of Directors voted during their meeting Friday to take an oppose unless amended position on SB 9 (Atkins), which would require a local government to ministerially approve a housing development containing two residential units in single-family residential zones.

Additionally, this measure would require local governments to ministerially approve urban lot splits.

SB 9 would require local governments to:

- Ministerially approve a housing development containing two residential units in singlefamily residential zones regardless of locally adopted and state certified housing plans.
- Allow a developer to convert an existing single-family home into a duplex and then add an
 accessory dwelling unit (ADU) and a junior accessory dwelling unit (JADU) to the same
 parcel, resulting in a total of four units.
- Ministerially approve a single-family lot split, creating two lots, and allowing the construction of one single-family home, one ADU, and one JADU on each lot for a total of six units on a parcel originally zoned for one single-family home.

Requested amendments:

- Clarify that a property owner using SB 9 is limited to constructing two residential units, not two residential units and additional accessory dwelling units (ADUs) on the same parcel.
- Require a housing developer to acquire a building permit within one year of a lot split, so that speculators do not sell lots and never build homes.
- Allow local governments to require adequate access for police, fire, and other public safety vehicles and equipment.
- Prohibit developers from using SB 9 in very high fire hazard severity zones.
- Allow cities to determine a range of lot sizes suitable for SB 9 development projects.
- Ensure the California Department of Housing and Community Development provides Regional Housing Needs Allocation (RHNA) credit for production of SB 9 units.

- Allow local governments to take into account local conditions such as hillsides, lot dimensions, natural hazards, available infrastructure, etc. when approving or denying housing project applications.
- Allow local governments to continue to determine parking standards.
- Ensure large-scale investors and builders do not exploit SB 9 provisions.

Next Steps

Cal Cities issued an action alert last week asking member cities to weigh in on the measure. SB 9 will be heard by the Senate Committee on Housing in the coming weeks. At this time, the bill has not been set for a hearing date. Cal Cities is encouraging cities to send in letters as soon as possible.

The Cal Cities Board of Directors also adopted the Housing, Community, and Economic Development Policy Committee's recommendation to oppose SB 55 (Stern), which would prohibit the creation or approval of a new commercial or residential development in a very high fire severity zone or a state responsibility area.

New affordable housing for low-income residents in the City of Santa Ana will be constructed with funding from the issuance of \$35.5 million in tax-exempt and taxable multi-family affordable housing bonds through the California Statewide Communities Development Authority (CSCDA).

Legacy Square Apartments is the new construction of 93 housing units in Santa Ana, which provides the community with one-, two-, and three-bedroom apartments to low-income residents.

CSCDA and the project sponsor, National Community Renaissance, partnered with Bank of America and Orrick Herrington & Sutcliffe LLP to provide \$35,500,000 million in affordable housing bonds to build the project. The project will ensure that 100 percent of the rental housing units will be rent restricted for low-income tenants, and affordable units will be restricted to households earning 30 percent, 50 percent, or 60 percent of the area median income. The financing for the project will maintain the affordability of units for low-income tenants for 55 years.

Cal Cities' co-sponsorship of CSCDA continues to be a significant benefit for cities. CSCDA has issued more than \$63 billion in tax-exempt bonds for projects that provide a public benefit by creating jobs, affordable housing, healthcare, infrastructure, schools, and other fundamental services.

CSCDA is a joint powers authority created in 1988 and is sponsored by the League of California Cities and the California State Association of Counties. More than 530 cities, counties, and special districts are program participants in CSCDA, which serves as their conduit issuer and provides access to efficiently finance locally-approved projects.

Solid waste and recycling costs on the rise in California
Cal Cities survey indicates anticipated rate increases statewide regardless of city
size

Cal Cities recently surveyed cities on solid waste and recycling rates to understand if rates are on the rise, by how much, and what is driving these cost increases.

A Cal Cities <u>infographic</u> shows cities of every size anticipate solid waste and recycling rate increases in the next three years.

California cities of every size anticipate solid waste and recycling rate increases in the next three years. Of the 149 cities surveyed, nine out of 10 cities indicated their rates are increasing, with more than seven out of 10 anticipating a 1 to 20 percent rate increase. <u>SB 1383</u> implementation costs and lack of associated infrastructure are the top factors for rate increases.

SB 1383, the state's new organic waste regulations, go into effect Jan. 1, 2022, and will add additional cost pressures to solid waste and disposal rates. CalRecycle finalized the SB 1383 regulations in November 2020, leaving cities only about a year to fully implement the ambitious regulations before they take effect.

Cities need additional time, flexibility, and a source of stable statewide funding to implement the new organic waste regulations. This will help cities realistically achieve shared climate and emission reduction goals and ensure this \$20 billion program does not fall on ratepayers in a time when California residents' budgets are tight.

Cal Cities delivers in first board meeting of 2021 with bill positions, new initiatives, swearing in of new members, and a conversation with Gov. Gavin Newsom

February 17, 2021

The League of California Cities Board of Directors gathered virtually for a two-day meeting last week to review progress on Cal Cities' 2021 Strategic Advocacy Priorities and Strategic Growth Plan goals, learn about new organization initiatives, vote on policy positions, and discuss with the Governor pressing issues facing California's cities.

Cal Cities President and El Centro Mayor Cheryl Viegas Walker kicked off with a recap of meetings that board officers, the executive director, and Cal Cities staff had so far in 2021 with both state and federal lawmakers, working to advance our <u>strategic advocacy priorities</u> as developed in December 2020 by the Cal Cities membership and League Leaders, and approved by the board. Members also received an update on <u>draft legislation</u> out of Washington, D.C. that includes \$350 billion in relief for states, city, counties, tribes and territories with no minimum population requirement.

Gov. Gavin Newsom joined the meeting virtually to discuss his Administration's priorities this year and answer questions from Cal Cities board members about emergency relief for cities from the state, support for small businesses, increasing housing supply without stripping cities of their local authority vaccine distribution, and wildfire prevention and preparedness.

The Governor committed to increasing the speed at which COVID-19 vaccines would be administered throughout the state with a goal of 4 million people vaccinated every week as the goal with the only limitation being the supply. Getting students back in school, providing \$2.7 billion in stimulus checks to Californians, and quadrupling small business grants to \$2 billion were also top priorities for his administration. The Governor thanked cities for the work they had done spending tens of millions of dollars to support small businesses during the pandemic.

As far as emergency relief to cities for continued response and recovery, the Governor acknowledged that cities hadn't received the support they needed, and after a deal is reached at the federal level, the state will review any additional need and see how it can provide support to local governments.

The Governor also committed to working with cities to address the crises of housing and homelessness in California communities. The Governor suggested that the state's efforts in this

area are not intended "to take over local planning, but help to incentivize and accelerate housing production and affordability." Cal Cities will continue to advocate with both the Administration and the Legislature to protect local control.

Cal Cities staff provided updates on current legislation before the state Legislature that impacts cities, including housing bill SB 9 (Atkins) and SB 55 (Stern). Read more about Cal Cities' policy committee recommendations for bill positions and the <u>board's vote</u>.

The board also held a special election to fill two at-large vacancies, confirming the presidential nominations of Palm Springs Mayor pro Tem Lisa Middleton and El Cerrito Mayor pro Tem Gabe Quinto. The following new board members were also welcomed and sworn in:

Several exciting new initiatives were also announced at the board meeting designed to make Cal Cities even stronger than it is today. President Viegas Walker announced members of the <u>Cal Cities Advancing Equity Advisory Committee</u>, a new committee charged with developing recommendations for the organization's future work supporting city efforts to advance equity in their communities. The committee will have a very important role in the coming months helping Cal Cities identify best practices, tools, and resources to support local efforts in this area. The committee's recommendations will go before the full board for approval.

Viegas Walker also announced members of a <u>Public Safety Task Force</u>, which will start work on the development of recommendations to modernize the approach to delivering public safety services in communities. The Public Safety Task Force will review and recommend updates to Cal Cities' public safety policy and guiding principles, which will be delivered to the Public Safety Policy Committee for consideration in April.

Progress on Cal Cities' Strategic Growth Plan was shared with the board including the framework to evaluate the organization's governance system, including the leadership selection process, and the timeline for the launch of a new brand identity for Cal Cities. In fact, the short name Cal Cities, launched in November, was the first public step in the new brand identity rollout.
