




The attached figures show the recent trend of water consumption in Orange County (OC), an estimate of Imported Water Sales for MWDOC, and selected water supply information.

- OC Water Usage, Monthly by Supply in April.

 OCWD Groundwater was the main supply in April.
- Estimated OC Water Usage, Monthly, Comparison to Previous Years
 Water usage in April 2021 was above average compared to the last 5 years.
 We are projecting a slight Increase in overall water usage compared to FY 2019-20. It has been 49 months since all mandatory water restrictions were lifted by the California State Water Resources Control Board.
- Historical OC Water Consumption Orange County M & I water consumption is projected to be 544,000 AF in FY 2020-21 (this includes ~15 TAF of agricultural usage and non-retail water agency usage). This is about 12,000 AF more than FY 2019-20 and is about 28,000 AF more than FY 2018-19. Water usage per person is projected to be slightly higher in FY 2020-21 for Orange County at 152 gallons per day (This includes recycled water). Although OC population has increased 20% over the past two decades, water usage has not increased, on average. A long-term decrease in per-capita water usage is attributed mostly to Water Use Efficiency (water conservation) efforts. O.C. Water Usage for the last five Fiscal Years is the lowest since the 1982-83 Fiscal Year (FY 1982-83 was the third wettest year on record).

<u>Water Supply Information</u> Includes data on Rainfall in OC; the OCWD Basin overdraft; Northern California and Colorado River Basin hydrologic data; the State Water Project (SWP) Allocation, and regional storage volumes. The data have implications for the magnitude of supplies from the three watersheds that are the principal sources of water for OC. Note that a hydrologic year is Oct. 1st through Sept. 30th.

- Orange County's accumulated precipitation through early June was below average for this period. Water year to date rainfall in Orange County is 5.7 inches, which is 45% of normal.
- Northern California accumulated precipitation through early May was 48% of normal for this period. Water Year 2020 was 63% of normal while water year 2019 was 137% of normal. The Northern California snowpack was 66% as April 1st As of early May, 100.00% of California is experiencing moderate to exceptional drought conditions while 100.00% of the state is experiencing abnormally dry conditions. The State Water Project Contractors Table A Allocation was lowered to 5% in March 2021.
- Colorado River Basin accumulated precipitation through late May was 75% of normal for this period. The Upper Colorado Basin snowpack was 74% of normal as of April 13th. Lake Mead and Lake Powell combined have about 51% of their average storage volume for this time of year and are at 35.6% of their total capacity. If Lake Mead's level falls below a "trigger" limit 1,075 ft. at the end of a calendar year, then a shortage will be declared by the US Bureau of Reclamation (USBR), impacting Colorado River water deliveries to the Lower Basin states. As of early June, Lake Mead levels were 1.50' BELOW the "trigger" limit. The USBR predicts that there is a 60% chance that the trigger level will be hit in 2022 and a 82% chance in 2023.






Accumulated Precipitation

for the Oct.-Sep. water year, late May 2021







2020 Urban Water Management Plan (2020 UWMP), Addendum to the 2015 UWMP on Reduced Delta Reliance Reporting, and Water Shortage Contingency Plan (WSCP)

The Metropolitan Water District of Southern California (Metropolitan) is pleased to submit its 2020 Urban Water Management Plan (UWMP), Addendum to the 2015 UWMP on Reduced Delta Reliance Reporting, and Water Shortage Contingency Plan (WSCP). Metropolitan's Board of Directors voted unanimously to adopt these plans on May 11, 2021.

The 2020 UWMP provides a representation of Metropolitan's planning elements reported under the conditions required by the UWMP Act and was developed as part of Metropolitan's 2020 Integrated Water Resources Plan process. The 2020 UWMP complies with the California Water Code (CWC) requiring urban water suppliers to prepare and update urban water management plans every five years.

The Addendum to the 2015 UWMP on Reduced Delta Reliance Reporting includes all of the elements described in Delta Plan Policy WR P1, Reduce Reliance on the Delta Through Improved Regional Water Self-Reliance (Cal. Code Regs. tit. 23, § 5003), which need to be included in a water supplier's UWMP to support a certification of consistency for a future covered action.

The WSCP presents Metropolitan's efficient management and planned actions to respond to actual water shortage conditions. Metropolitan's WSCP satisfies the requirements of the CWC. Complete copies of the 2020 UWMP, Addendum to the 2015 UWMP, and WSCP are also posted on Metropolitan's website www.mwdh2o.com.

AMENDMENT TO THE PROCLAMATION OF AN EMERGENCY PROGRAM AGAINST THE HUANGLONGBING DISEASE

FOR COMMUNITIES IN ORANGE COUNTY

Between April 11, 2017 to May 7, 2021, the California Department of Food and Agriculture (CDFA) confirmed the presence of the causative bacterial agent of the citrus disease huanglongbing (HLB) in citrus tree tissue collected in the cities of Anaheim, Fountain Valley, Fullerton, Garden Grove, Huntington Beach, La Habra, Orange, Placentia, Santa Ana, Tustin, Westminster, and Yorba Linda, in Orange County.

HLB is a devastating disease of citrus and is spread through feeding action by populations of the Asian citrus psyllid (ACP), *Diaphorina citri* Kuwayama. In order to determine the extent of the infestation, and to define an appropriate response area, additional surveys took place for several days over a 250-meter radius area, centered on the detection sites. Based on the results of the surveys, implementation of the CDFA's ACP and HLB emergency response strategies are necessary for eradication and control. The Proclamation of Emergency Program and associated Notice of Treatment are valid until May 7, 2022, which is the amount of time necessary to determine that the treatment was successful.

HLB is considered the most devastating disease of citrus in the world. In the United States, HLB's unchecked spread in Florida starting in 2006 resulted in devastating impacts on the environment and economy. Symptoms of HLB include yellow shoots with mottling and chlorosis of the leaves, misshapen fruit, fruit that does not fully color, and fruit that has a very bitter taste, which makes it unfit for human consumption. These symptoms often do not appear until two years after infection, making this particular disease difficult to contain and suppress. The bacterium that causes the disease, namely *Candidatus* Liberibacter asiaticus, blocks the flow of nutrients within the tree, causing the tree to starve to death. There is no cure, and trees infected with the disease will die two to five years after infection. The undesirable symptoms of HLB-infected trees result in the trees' loss of commercial and aesthetic value while they remain hosts for spreading HLB to ACP and other plants. These effects would be catastrophic to California's natural environment, agriculture, and economy. For example, the effect of HLB's establishment in Florida resulted in a citrus industry loss of \$7 billion. Similar consequences can be expected in California, where the citrus industry is valued at \$2.2 billion.

ACP feeds on members of the plant family Rutaceae, primarily on *Citrus* and *Murraya* species, but is also known to attack several other genera, including over forty species of plant that act as hosts and possible carriers. The most serious damage to the environment and property caused by ACP—the death and loss in value of host plants—is due to its vectoring the phloem-inhabiting bacteria in the genus *Candidatus* Liberibacter. However, the psyllids also cause injury to their host plants via the withdrawal of large amounts of sap as they feed, and via the production of large amounts of honeydew, which coats the leaves of the tree and encourages the growth of sooty mold. Sooty mold blocks sunlight from reaching the leaves.

On November 22, 2017, the University of California and the United States Department of Agriculture (USDA) released a briefing paper that indicates, beginning in June 2017, a sharp increase in HLB and HLB-positive ACP detections, cities containing HLB, and ACP nymphs. Prior to the release of the November 22, 2017 briefing paper, the level of HLB risk in California

was thought to be relatively stable. Following the release of the November 22, 2017 briefing paper, the Department has become aware of the exponential intensification of the HLB epidemic, as demonstrated by the indicators contained in the paper.

Considering the exponential intensification of the HLB epidemic, emergency action is needed to protect California from the negative environmental and economic impact HLB will cause should it be allowed to remain in this area. The emergency program is based on recommendations developed in consultation with the California HLB Task Force, USDA experts on HLB and ACP, the Primary State Entomologist, the Primary State Plant Pathologist, and the affected counties agricultural commissioners' representatives who are knowledgeable on HLB and ACP Incorporating these experts' recommendations and findings, the program requires removal of all HLB-infected trees.

In determining how to respond to this emergency, the CDFA employs integrated pest management (IPM) principles. IPM includes cultural, biological, physical, and chemical control methods. The CDFA considered all relevant factors, data and science and determined that cultural, biological, and chemical control methods would not abate the imminent threat posed by HLB-positive trees or meet its statutory obligations. Therefore, a physical method was selected, which includes removal of any infected host plant. This option was selected based upon minimal impacts to the environment, biological effectiveness, minimal public intrusiveness, and cost.

The November 22, 2017 briefing paper revealed the exponential intensification of the HLB epidemic, which necessitates immediate action to address the epidemic's imminent threat to California's natural environment, agriculture and economy. More specifically, in addition to citrus, the HLB/ACP complex threatens loss and damage to native wildlife, private and public property, and food supplies.

In addition, the Secretary is mandated to: thoroughly investigate the existence of the disease; determine the probability that the disease will spread; adopt regulations as are reasonably necessary to carry out the provisions of this code (title 3, California Code of Regulations, section 3591.21); abate the disease from the established treatment area; and prevent further economic damage. See FAC sections 401, 403, 408, 5401-5405, and 5761-5763.

A Program Environmental Impact Report (PEIR) has been prepared which analyzes the ACP and HLB treatment program in accordance with Public Resources Code (PRC), section 21000 et seq. The PEIR was certified in December 2014, and is available at http://www.cdfa.ca.gov/plant/peir/.

The treatment plan for the HLB infestation shall be implemented as follows:

1. Physical Control. All host plants found to be infected with HLB will be removed and destroyed using mechanical means in order to stop the spread of the disease.

Public Notification:

Residents of affected properties shall be invited to a public meeting or contacted directly by CDFA staff. Consultation with the California Department of Pesticide Regulation, the Office of Environmental Health Hazard Assessment, and the county agricultural commissioner's office will be provided at the public meeting or upon request to address residents' questions and concerns.

Residents shall be notified in writing at least 48 hours in advance of any treatment in accordance with the Food and Agricultural Code sections 5771-5779 and 5421-5436. For any questions related to this program, please contact the CDFA toll-free telephone number at 800-491-1899 for assistance. This telephone number is also listed on all treatment notices. Treatment information is posted at http://cdfa.ca.gov/plant/acp/treatment maps.html.

Following the treatment, completion notices are left with the residents detailing precautions to take and post-harvest intervals applicable to the citrus fruit on the property.

Press releases, if issued, are prepared by the CDFA information officer and the county agricultural commissioner in close coordination with the program leader responsible for treatment. Either the county agricultural commissioner or the public information officer serves as the primary contact to the media.

Information concerning the HLB/ACP program shall be conveyed directly to local and State political representatives and authorities via letters, emails, and/or faxes.

Enclosed are the findings regarding the treatment plan, the November 22, 2017 UC and USDA briefing paper, maps of the treatment area, work plan, integrated pest management analysis of alternative treatment methods, and a pest profile.

FINDINGS OF AN EMERGENCY FOR ASIAN CITRUS PSYLLID/HUANGLONGBING

Orange County Program CS-9092

Between April 11, 2017 to May 7, 2021, the California Department of Food and Agriculture (CDFA) confirmed the presence of the causative bacterial agent of the citrus disease huanglongbing (HLB) from citrus tree tissue collected in the cities of Anaheim, Fountain Valley, Fullerton, Garden Grove, Huntington Beach, La Habra, Orange, Placentia, Santa Ana, Tustin, Westminster, and Yorba Linda, in Orange County. HLB is a devastating disease of citrus and is spread through feeding action by populations of the Asian citrus psyllid (ACP), *Diaphorina citri* Kuwayama.

Additional surveys were conducted by CDFA in order to determine the extent of the infestation in Orange County and to define an appropriate response area. Each survey took place for several days over a 250-meter radius area, centered on the following detections: June 14, 2017, Fullerton; May 25, 2018, Yorba Linda; June 18, 2019, La Habra; November 20, 2019, Placentia; March 13, 2020, Westminster; July 3, 2020, Fountain Valley; August 28, 2020, Tustin; December 24, 2020, Huntington Beach; March 18, 2021, Garden Grove and Orange; May 7, 2021, Anaheim and Santa Ana. Based on these surveys, and findings and recommendations from California's HLB Task Force, the Primary State Entomologist, the Primary State Plant Pathologist, USDA experts on HLB and ACP, and County Agricultural Commissioner representatives who are knowledgeable on HLB and ACP, I have determined that HLB poses a statewide imminent danger to the environment and economy.

The results of the additional surveys also indicated that the local infestation is amenable to CDFA's ACP and HLB emergency response strategies, which include removal of any infected host plant. This option was selected based upon minimal impacts to the natural environment, biological effectiveness, minimal public intrusiveness, and cost.

HLB is considered one of the most devastating diseases of citrus in the world. The bacterium that causes the disease, namely *Candidatus* Liberibacter asiaticus, blocks the flow of nutrients within the tree and causes the tree to starve to death within two to five years of infection. There is no cure. Symptoms of HLB include yellow shoots with mottling and chlorosis of the leaves, misshapen fruit, fruit that does not fully color, and fruit that has a very bitter taste, which makes it inedible for human consumption. These symptoms often do not appear until two years after infection, making this particular disease difficult to contain and suppress. These undesirable symptoms of HLB-infected trees result in the trees' loss of commercial and aesthetic value while at the same time they are hosts for spreading HLB.

ACP is an insect pest that is native to Asia. It has appeared in Central and South America, the Caribbean, and Mexico. In the United States, ACP has been found in Alabama, Arizona, Florida, Georgia, Hawaii, Louisiana, Mississippi, South Carolina, and Texas. In California, ACP has been found in twenty-eight counties.

ACP feeds on members of the plant family Rutaceae, primarily on *Citrus* and *Murraya* species, but is also known to attack several other genera, including over forty species of plant that act as hosts and possible carriers. The most serious damage to the environment and property caused by ACP—the death and loss in value of host plants—is due to its vectoring the phloem-inhabiting bacteria in the genus *Candidatus* Liberibacter. In addition, the psyllids also cause injury to their host plants via the withdrawal of large amounts of sap as they feed and via the production of large amounts of honeydew, which coats the leaves of the tree and encourages the growth of sooty mold. Sooty mold blocks sunlight from reaching the leaves.

These pests present a significant and imminent threat to the natural environment, agriculture, and economy of California. For example, unabated spread of HLB would have severe consequences to both the citrus industry and to the urban landscape via the decline and the death of citrus trees. The

value of California citrus production in the 2016-17 marketing year was \$3.389 billion. The total economic impact of the industry on California's economy in 2016-17 was \$7.1 billion. The California citrus industry added \$1.695 billion to California's state GDP in 2016. Estimated full time equivalent jobs in the California citrus industry in 2016-17 totaled 21,674. Estimated wages paid by the California citrus industry income in 2016-17 totaled \$452 million. A 20 percent reduction in California citrus acreage would cause a loss of 7,350 jobs, \$127 million in employee income, and reduce state GDP by \$501 million.

Additionally, if unabated, the establishment of HLB in California would harm the natural environment as commercial and residential citrus growers would be forced to increase pesticide use. And, the establishment of HLB could lead to enforcement of quarantine restrictions by the USDA and our international trading partners. Such restrictions would jeopardize California's citrus exports, which are valued at over \$800 million per year.

The causative bacteria of HLB was first detected in Los Angeles in 2012. It has subsequently been detected in Orange, Riverside, San Bernardino, and San Diego counties. Prior to November 2017, the level of HLB risk in California was thought to be relatively stable. However, on November 22, 2017, the University of California and the United States Department of Agriculture released a briefing paper that indicates, beginning in June 2017, a sharp increase in HLB and HLB-positive ACP detections, cities containing HLB, and ACP nymphs. Following the release of the November 22, 2017 briefing paper, the Department has become aware of the exponential intensification of the HLB epidemic, as demonstrated by the indicators contained in the paper.

Infected trees are destroyed as soon as they are discovered. However, due to the length of time it takes for symptoms to appear on infected trees, new infestations continue to be discovered. If the current infestation is not abated immediately, HLB will likely become established in neighboring counties and could pave the way for a statewide HLB infestation.

The CDFA has evaluated possible treatment methods in accordance with integrated pest management (IPM) principles. As part of these principles, I have considered the following treatments for control of HLB: 1) physical controls; 2) cultural controls; 3) biological controls; and 4) chemical controls. Upon careful evaluation of each these options, I have determined that it is necessary to address the imminent threat posed by HLB using currently available technology in a manner that is recommended by the HLB Task Force.

Based upon input from the HLB Task Force, the Primary State Entomologist, the Primary State Plant Pathologist, USDA experts on HLB and ACP, and county agricultural commissioner representatives who are knowledgeable on ACP and HLB, I find there are no cultural, chemical or biological control methods that are both effective against HLB-positive trees and allow CDFA to meet its statutory obligations, and therefore it is necessary to conduct physical and chemical treatments to abate this threat. As a result, I am ordering removal of all HLB-infected trees.

A Program Environmental Impact Report (PEIR) has been prepared which analyzes the ACP and HLB treatment program in accordance with Public Resources Code (PRC), section 21000 et seq. The PEIR was certified in December 2014 and is available at http://www.cdfa.ca.gov/plant/peir/. The PEIR addresses the treatment of the ACP and HLB at the program level and provides guidance on future actions against the ACP and HLB. It identifies feasible alternatives and possible mitigation measures to be implemented for individual ACP and HLB treatment activities. The ACP and HLB program have incorporated the mitigation measures and integrated pest management techniques as described in the PEIR. In accordance with PRC section 21105, this PEIR has been filed with the appropriate local planning agency of all affected cities and counties. No local conditions have been detected which would justify or necessitate preparation of a site-specific plan.

The CDFA has consulted with the California Department of Fish and Wildlife's California Natural Diversity Database for threatened or endangered species, the United States Fish and Wildlife Service, the National Marine Fisheries Service and the California Department of Fish and Wildlife when rare and endangered species are located within the treatment area. Mitigation measures for rare and endangered species will be implemented as needed. The CDFA shall not apply pesticides to bodies of water or undeveloped areas of native vegetation. All treatment shall be applied to residential properties, common areas within residential development, non-agricultural commercial properties, and rights-of-way.

Work Plan

The proposed treatment area encompasses those portions of Orange County which fall within a 250-meter radius area around the property on which HLB has been detected, and any subsequent detection sites within the treatment area boundaries. The Proclamation of Emergency Program and associated Notice of Treatment are valid until May 7, 2022, which is the amount of time necessary to determine that the treatment was successful. Maps of the treatment area boundaries are attached. The work plan consists of the following elements:

1. Physical Control. All host plants found to be infected with HLB shall be destroyed. Infected host plants shall be removed and destroyed using mechanical means.

Public Information

Residents of affected properties shall be invited to a public meeting or contacted directly by CDFA staff. Consultation with the California Department of Pesticide Regulation, the Office of Environmental Health Hazard Assessment, and the county agricultural commissioner's office will be provided at the public meeting or upon request to address residents' questions and concerns.

The resident of an affected property is provided a confirmation letter informing them that a tree on their property is infected with HLB and it is subject to mandatory removal. Residents are directed to contact the CDFA toll-free telephone number at 800-491-1899 for assistance.

Findings

HLB poses a significant, imminent threat to California's natural environment, agriculture, public and private property, and its economy.

The work plan involving physical control of this pest is necessary to prevent loss and damage to California's natural environment, citrus industry, native wildlife, private and public property, and food supplies.

My decision to adopt findings and take action is based on FAC sections 24.5, 401.5, 403, 407, 408, 5401-5405, and 5761-5764.

GARDEN GROVE — Police said they made 19 arrests Wednesday evening at an illegal gambling operation in a Garden Grove neighborhood.

Police responded about 7 p.m. to the 10000 block of McMichael Drive, near Brookhurst Street and north of Chapman Avenue, and determined a residence "was in fact operating as an illegal gambling establishment," according to Sgt. Troy Haller of the Garden Grove Police Department.

A search warrant was served at the home and 12 gambling machine consoles and a gun were found and seized, Haller said.

Officers arrested 19 people for illegal gambling violations and/or outstanding arrest warrants, Haller said.

Garden Grove Police officer charged with beating, threatening homeless people

SANTA ANA — A 12-year veteran of the Garden Grove Police Department was charged Wednesday with beating and threatening two homeless people in separate incidents while on duty.

Kevin Dinh, 38, is scheduled to be arraigned July 21 on four counts of attempted criminal threats, two counts of battery and two counts of assault and battery by an officer, all misdemeanors.

Dinh, who is on administrative leave, could face up to four years in jail if convicted as charged.

Last Sept. 20, Dinh and another officer were sent to a restaurant when some homeless people refused to leave the front of the eatery, according to Kimberly Edds, a spokeswoman for the District Attorney's Office. Dinh allegedly struck one of the transients in the back of the head and twisted the man's hands behind his back before threatening to knock his teeth out if he saw him again, Edds said.

On a call to an Orange County Transportation Authority bus stop last Oct. 18 regarding a package thief, Dinh allegedly struck a handcuffed suspect in the head and grabbed and pulled his hair before he was let go, Edds said.


Garden Grove police said Dinh has been placed on leave amid an internal probe.

"We will not tolerate this behavior on any members of our community," Garden Grove Police Chief Tom DaRe said. "Everyone will be treated with dignity and respect."

"Although we believe these are isolated incidents, if there are any other victims, we encourage them to contact the Garden Grove Police Department Detective Bureau at (714) 741-5800," a police statement said.

Orange County District Attorney Todd Spitzer said: "The public has the expectation that its law enforcement officers treat everyone with dignity and respect. Abusing the color of authority to exert unlawful force or to attempt to instill fear in detained suspects is not how the overwhelming majority of police officers conduct themselves, and when officers cross the line into criminal behavior, they will be held accountable."



"And through art," she added. "our young people share a collective voice in sending out a message to protect our oceans."

For nearly 30 years, the Malibu Foundation for Environmental Education has held inperson assemblies at elementary schools throughout Southern California, culminating the program with a clean-up event at Dockweiler State Beach, in Los Angeles County, on World Ocean Day.

The program is funded and supported by the California Coastal Commission, the City of Los Angeles Board of Public Works, and LA Sanitation & Environment.

But because of the coronavirus pandemic, the foundation shifted to holding virtual presentations and a statewide student art contest. The foundation revealed the winners on Tuesday, June 8, which was World Ocean Day.

All of the entries were combined to form a mosaic based on the winning entry, with various ocean life — including a jelly fish, seat turtle and dolphins — swimming around a heart.

Pandemic fuels struggle to buy baby diapers

Orange County Diaper Bank and others look for donations and \$30 million boost from state.

Struggling parents with children still in diapers may get a \$30 million boost under a proposed state budget allocation to assist existing diaper banks in California and launch similar services in other regions, including San Bernardino County.

Money for the five state-funded diaper banks now in operation – in Los Angeles, Orange, San Diego, Fresno and San Francisco counties – and three new ones would extend over a three-year period, with each diaper bank receiving a total of \$3.75 million under the spending plan proposed by Assemblywoman Lorena Gonzalez, D-San Diego, and supported by a host of Southern California legislators.

Job loss and other economic hardships imposed on families by the <u>coronavirus</u> pandemic, along with spikes in the cost of disposable diapers, is sending more parents with young children to the diaper banks and other social service organizations looking for help.

Just as COVID-19 sparked food insecurity on a scale not seen before by local food banks, demand for diaper assistance rose exponentially over the past year, say

operators of the five state-subsidized diaper banks, which are part of the National Diaper Bank Network.

Community Action Partnership of Orange County operates one of the county's two food banks and its only community-based diaper bank, which is part of the National Diaper Bank Network. Since it launched, the service has distributed 10.7 million diapers – in allotments of 50 diapers a month per child. That adds up to diapering an average of 37,000 baby bottoms a month.

"The need for diapers is a crisis," said Gregory Scott, president and chief executive officer of the nonprofit.

"Just as food and hunger is a crisis."

Strong support

In a letter authored by Gonzalez and addressed to leaders in the state legislature who are working on budget negotiations under a June 15 deadline, more than two dozen Southern California state legislators, from both sides of the aisle, signed their support for extending and expanding the state's Diaper Bank Program.

The initial round of funding for the diaper program, pushed for by Gonzalez and established in 2018, is set to expire this year. The diaper banks rely as well on contributions of cash and donations of diapers, mainly through diaper drives, such as HomeAid Orange County's annual <u>Essentials Diaper Drive</u> that takes place during May and June.

Orange County is the most recent of the five state-subsidized diaper banks, approved in 2019 and awarded \$1.7 million in funding for two years. It launched on March 18, 2020, right at the start of the statewide COVID-19 shutdown. The diapers are provided free to eligible families served by 70 partner agencies in a collaborative network.

The \$30 million request would boost the annual allotment to each diaper bank by \$250,000. And besides creating a new diaper bank in the Inland Empire to be run by Community Action Partnership of San Bernardino County, which also oversees a food bank, the proposed new funding would expand the state program to Sacramento and Sonoma counties.

Community Action Partnership in San Bernardino works with more than 250 organizations to distribute food, hygiene products and other items. "Diapers are always at the top of the list of needed items," said Patricia L. Nickles-Butler, president and chief executive officer.

Requests for diapers are made on a daily basis, and in a recently completed community needs assessment, 58% of responses identified diapers as a "high need," Nickles-Butler said.

The pandemic has only worsened the need, especially among single parents, diaper bank supporters say.

"Long before the pandemic, one in three families across the country struggled to afford enough diapers and Latina and Black mothers were significantly more likely to report diaper need," the letter authored by Assemblywoman Gonzalez states, citing findings from a peer-reviewed study published in the Journal of the American Academy of Pediatrics in 2013.

"Now, more than 2.1 million Californians remain unemployed" and face tough choices, the letter continues.

"Many families must decide between buying diapers or groceries or paying their rent."

Cost increases

The families served by the Community Action Partnership organizations in Orange and San Bernardino counties have tended to be people with jobs in the service industry that was hit hard by the economic shutdown during the pandemic. But there are new faces among them – folks with once-comfortable middle-class lifestyles, Scott said.

"Sometimes we take for granted something so basic as diapers for our babies. But for some families, that's a big expense."

Companies that make disposable diapers, including Kimberly-Clark and its Huggies and Pull-Ups brands, have already started raising prices or announced hikes in the near future – part of increased costs of household goods as the economy improves. Under the headline, "Millions of Americans about to get hit with diaper sticker shock," CNN reported in April that both Kimberly-Clark and Procter & Gamble (Pampers, Luvs and All Good diapers) planned mid-to-high single-digit percentage increases.

That news came on top of an 8.7% hike in disposable diaper prices during the year that ended April 10, according to CNN's reporting on NielsenlQ's tracking of retail sales data.

At a Target in Santa Ana on Friday, June 4, a 124-count package of Huggies "Snug & Dry" Size 1 disposable diapers (for babies 8 to 14 pounds) was priced at \$24.99; a 168-count package of Size 3 for children 16 to 28 pounds cost \$37.99. Online at Walmart.com, a 256-count of the same Size 1 diapers cost \$48.47; a 210-count of Size 3 sold for \$83.28 — both described as a one-month supply.

The expense is only compounded if more than one child is still in diapers. And baby wipes go along with that.

At best, diaper banks – either through free or low-cost fees – supplement what parents buy on their own. According to research by the National Diaper Bank

Network, parents tend to end up about a dozen diapers short by the end of every week.

The monthly 50 diapers per baby from the Orange County Diaper Bank, Scott said, "is meant to fill that gap."

Diaper drive

Because of the economic impact of COVID-19 and diaper price increases, the Orange County Diaper Bank coronavirus relief from the state has allowed distribution of an additional monthly box of diapers – with anywhere from 64 to 104 diapers, depending on diaper size – per child, said diaper bank manager Natalie Anderson.

Through the end of 2020, the diaper bank provided surplus diapers to 15 to 20 additional local organizations outside of its regular collaborative network of 40 agencies. But in just the past six months, that number climbed to 30, Anderson said.

Even with the subsidy from the state, donations from the community have been and will remain vital to keep up with demand, diaper bank operators say.

Last year, <u>a mostly digital</u> HomeAid Essentials Diaper Drive, the single largest such effort in Orange County, collected 960,000 diapers for families experiencing homelessness. Businesses, service groups and others host sites for diaper collection over several weeks.

About 20 sites open to the public for this year's drive are listed online at https://no.com/homeaidoc.org/events/2021-essentials-diaper-drive/; donations also can be made through HomeAid Orange County's Amazon.com registry at buff.ly/38EaZJJ. The drive ends on Friday, June 11, when the collected diapers will be dropped off from 10 a.m. to 2 p.m. in the parking lot off Lewis Street at Christ Cathedral, 13280 Chapman Ave, Garden Grove. Individual donors can also drop off packaged diapers and baby wipes that day. And, as is tradition, people who make a living building homes will compete-in-creating-mini-structures using packaged diapers. "We will still have diaper structures from local homebuilding teams, all showcasing something iconic from California," said Gina Scott, executive director of HomeAid Orange County.

CITY PROMOTES SAFE AND SANE FIREWORK USE, WARNINGS FOR INCREASED PATROL

As July 4 approaches, the City of Garden Grove, in collaboration with the Garden Grove Police Department and Orange County Fire Authority, reminds the community to take necessary precautions to ensure a safe and memorable celebration. Only safe and sane fireworks bearing the California State Fire Marshal seal may be discharged in Garden Grove on July 4, from 10:00 a.m. to 10:00 p.m., on private property only.

Through July 4, the Garden Grove Police Department will deploy additional police patrols to identify violators of the City's municipal code on fireworks. Individuals caught using or possessing illegal fireworks, or misusing or tampering with legal ones, will be cited a \$1,000 administrative fine. Multiple fines will be issued for repeat violators.

To report illegal fireworks, call the Garden Grove Police Department's nonemergency number at (714) 741-5704. Be prepared to provide the address where the illegal fireworks were lit and a description of the individual(s) involved. Call 9-1-1 for emergencies only.

On July 4, Garden Grove Animal Care Services will have an Animal Control Officer on-duty. If a pet goes missing, call (714) 741-5565, press 1, and leave a detailed voice message. The on-duty officer will be notified.






Một cảnh sát viên gốc Việt của Garden Grove bị truy tố đánh người

GARDEN GROVE, California (NV) – Một cảnh sát viên gốc Việt của Garden Grove bị truy tố vì đe dọa và đánh đập người vô gia cư trong giờ làm việc.

Theo thông cáo của Sở Cảnh Sát Garden Grove, cảnh sát viên Kevin Đinh bị truy tố hai tội danh tiểu hình cảnh sát đánh đập người khác trái phép, hai tội tiểu hình tấn công người khác, và bốn tội danh tiểu hình đe dọa người khác.

Nếu bị kết tội hết các tội danh nói trên, cảnh sát viên này sẽ nhận bản án tối đa bốn năm tù.

Sở Cảnh Sát Garden Grove cho biết ông Kevin làm việc cho cơ quan này đến nay được 12 năm, và đang bị cho tạm nghỉ việc.

Vào ngày 20 Tháng Chín, 2020, ông Kevin và một cảnh sát viên đến một tiệm ăn vì một số người vô gia cư gây cản trở ở cửa trước của doanh nghiệp này. Ông bị tố cáo đánh vào sau đầu của một

người gia cư khi đang khóa tay người đó. Ông còn bị tố cáo bẻ tay người vô gia cư đó, và dọa sẽ đánh người đó gãy răng nếu gặp lại.

Đến ngày 18 Tháng Mười, ông cùng hai cảnh sát viên đến một trạm xe buýt để điều tra một vụ ăn cắp đồ ở gần đó. Tại đây, ông bị tố cáo đánh vào đầu nghi can đang bị còng tay, sau đó nắm tóc của người đó và nói vài lời. Cuối cùng, nghi can được tháo còng tay và được thả.





SB 9 advances out of Assembly Local Government Committee despite strong Cal Cities opposition

June 9, 2021

The League of California Cities delivered the lead opposition testimony against SB 9 (Atkins) in today's Assembly Local Government Committee.

Despite robust opposition from city officials, local government advocates, community advocates, and others, the committee passed SB 9 on a 5-1 vote, with two abstentions.

SB 9, as presently drafted, would require cities to ministerially approve, without condition, discretion, or public input, a housing development containing two residential units on an individual parcel in single-family neighborhoods. Additionally, this measure would require local governments to ministerially approve an urban lot split, thus creating two independent lots that may be sold separately.

Nearly all cities are currently updating their housing plans to identify sites for more than two million new homes throughout California over the next eight years. SB 9 is a top-down, one-size-fits-all approach to land use policy that would disregard this process and mandate more housing in existing single-family zones without any evidence that this measure would result in more affordable housing.

By forcing unproven policies upon cities that would undermine local planning, change the rules mid-stream, or conflict with the myriad of new housing laws recently passed that cities are now implementing, SB 9 is certain to cause disruption to cities trying to implement their state-certified housing plans.

Jason Rhine, Cal Cities Assistant Legislative Director, delivered the opposition testimony on behalf of California cities. "We can all agree that housing affordability and homelessness are among the most critical issues facing California cities," said Rhine. "Unfortunately, SB 9 will not spur much needed housing construction in a manner that supports local flexibility, decision making, and community input."

State-driven ministerial or by-right housing approval processes, like the ones outlined in SB 9, fail to recognize the extensive public engagement associated with developing and adopting zoning ordinances and housing elements that are certified by the California Department of Housing and Community Development.

"SB 9 would ignore this long-standing, state-mandated housing planning process and instead force

cities to approve new housing that may conflict with certified housing plans," said Rhine.

Cal Cities has worked with the author and her staff for several months on amendments that would have addressed cities' primary concerns with the bill. These proposed amendments included:

- Clarify that a property owner using SB 9 is limited to constructing two residential units, not two residential units and additional accessory dwelling units (ADUs) on the same parcel.
- Require a housing developer to acquire a building permit within one year of a lot split, so that speculators do not sell lots and never build homes.
- Allow local governments to require adequate access for police, fire, and other public safety vehicles and equipment.
- Prohibit developers from using SB 9 in very high fire hazard severity zones.
- Allow cities to determine a range of lot sizes suitable for SB 9 development projects.
- Ensure HCD provides Regional Housing Needs Allocation (RHNA) credit for production of SB 9 units.
- Allow local governments to take into account local conditions such as hillsides, lot dimensions, natural hazards, available infrastructure, etc. when approving or denying housing project applications.
- Allow local governments to continue to determine parking standards.
- Ensure large-scale investors and builders do not exploit SB 9 provisions.

No agreement was reached, and as a result, Cal Cities changed its position on SB 9 from oppose unless amended to oppose. More than 175 cities have submitted letters of opposition or oppose unless amended since the bill's introduction.

SB 9 now moves to the Assembly Housing and Community Development Committee. Cal Cities urges all cities to call or submit a letter to their Assembly Members and urge them to oppose SB 9 and uphold local government decision-making and community involvement in housing plans.

Cal Cities-sponsored bond agency issues nearly \$20.7 million in tax-exempt bonds for affordable housing in Salinas

June 9, 2021

New affordable housing in the city of Salinas will be available for low-income residents, with nearly \$20.7 million in tax-exempt affordable housing bonds issued through the California Statewide Communities Development Authority (CSCDA).

Steinbeck Commons Apartments in Salinas is the acquisition and rehabilitation of 100 affordable housing units, which provides the community with apartments to low-income senior residents. All the units will remain 100% affordable for low-income senior residents in Salinas.

CSCDA and the project sponsor, MacDonald Ladd Development, partnered with Stifel, Berkadia, and Orrick, Herrington & Sutcliffe, LLP to provide the \$20,675,000 in tax-exempt multifamily affordable housing bonds to renovate the project.

The newly renovated affordable housing project will ensure that residents have an updated, safe, and affordable community to call home for years to come. The financing for this project will maintain the affordability of units for low-income tenants for 55 years.

Since its beginning, CSCDA has financed the construction or preservation of nearly 100,000 affordable units throughout California. Despite these efforts, affordable housing for all income levels still remains in short supply.

The League of California Cities' co-sponsorship of CSCDA continues to be a significant benefit for Cal Cities members. CSCDA has issued more than \$63 billion in tax-exempt bonds for projects that provide a public benefit by creating jobs, affordable housing, healthcare, infrastructure, schools, and other fundamental services.

CSCDA is a joint powers authority created in 1988 and is sponsored by Cal Cities and the California State Association of Counties. More than 530 cities, counties, and special districts are program participants in CSCDA, which serves as their conduit issuer and provides access to efficiently financed, locally-approved projects.

Guide to Local Recovery Update: June 9

June 9, 2021

The California Department of Finance (DOF) unveiled its <u>American Rescue</u> <u>Plan Local Fiscal Recovery Fund webpage</u> for non-entitlement cities and discussed the upcoming funding portal with city officials during a League of California Cities webinar earlier today.

The program covered the state's responsibilities, eligible usages, the application and distribution process, reporting requirements, and the portal itself. The webinar included a robust Q & A and is <u>available for review</u>, along with the <u>presentation slides</u>.

The National League of Cities will host a webinar about <u>the American Rescue Plan's impact on small businesses</u> on June 11. Additionally, the U.S. Department of the Treasury released new <u>June 8 Coronavirus State and Local Fiscal Recovery Funds FAQs</u>. More resources about the American Rescue Plan can be found in the "Federal Guidance and Resources" tab of Cal Cities' <u>Guide to Local Recovery webpage</u>.

The Federal Communications Commission (FCC) announced a \$7.17 billion "Emergency Connectivity Fund." Created as part of the American Rescue Plan, the Fund will enable schools and libraries to purchase laptop and tablet computers, Wi-Fi hotspots, and provide broadband connectivity for students, school staff, and library patrons in need during the pandemic. The FCC has not announced the dates for the first application window, but will provide advance notice of the opening so that eligible schools, libraries, and consortia can be ready to file their applications.

Finally, Gov. Gavin Newsom announced that the State would extend relief measures allowing restaurants and bars to continue expanded outdoor operations in areas such as sidewalks and parking lots and continue the sale of to-go alcoholic beverages with food deliveries. In a <u>letter</u> to city officials, he encouraged cities to facilitate outdoor dining through local zoning and programs that support and promote open-air, take-out, and delivery options.

State public utility commission issues decision on undergrounding program with mixed outcome for cities

June 8, 2021

The California Public Utilities Commission (CPUC) issued a decision this week on its Rule 20 undergrounding program, which lays out guidelines and procedures for the ratepayer-funded undergrounding of overhead electric facilities.

CPUC issued <u>Decision 21-06-013</u> on June 7 after considering revisions to their Rule 20 program over the past year. The decision reflected key recommendations by the League of California Cities, which were included in <u>submitted comments</u> outlining concerns with the CPUC's proposed revisions. However, other important requests were rejected.

Cal Cities advocated against the proposal to sunset the Rule 20A program so cities could continue to pursue ratepayer-funded undergrounding projects. Cal Cities also requested that cities be able to borrow, sell, or trade work credits. Additionally, Cal Cities asked for Rule 20A project eligibility to be expanded to promote wildfire safety and emergency-related undergrounding.

The CPUC decision includes some of Cal Cities' requests, including the decision not to sunset the Rule 20A program and the implementation of safeguards that will ensure Investor Owned Utilities (IOU) comply with additional transparency and accountability measures. However, other Cal Cities' recommendations were rejected.

The decision includes the following significant changes to the Rule 20 program that impact cities:

- CPUC will cease allocating work credits to cities through the program after Dec 31, 2022.
- CPUC prohibits utilities from authorizing cities to borrow, sell, or trade work credits from other jurisdictions, unless a county wants to redistribute its work credits to cities within its jurisdiction or neighboring cities want to pool credits for a common project.

Notably, the CPUC directed IOUs to work together with Cal Cities and other stakeholders on an updated Rule 20 Guidebook, which will detail the costs and responsibilities of each party at each stage of Rule 20 undergrounding projects, IOU contacts for projects, a timeline to anticipate annual reports, and links to the Rule 20 program webpages of the Commission and the IOUs. These transparency measures are intended to assist cities in understanding and utilizing the Rule 20 program.

The CPUC decided to defer consideration of several issues that are important to Cal Cities members to a "Phase 2" of the rulemaking proceeding, including:

- 1. Whether to add Rule 20A project eligibility criteria for wildfire safety and emergency-related undergrounding.
- 2. Whether to modify the Rule 20A program to support projects in underserved and disadvantaged communities.
- 3. Whether to take additional steps to support the completion of active Rule 20A projects.

Cal Cities will continue to advocate for the best interest of cities in this rulemaking and will be submitting comments on future phases of this rulemaking.
